Dear Mr. Carter:

I have received your report and sketch of June 27, 1952 delineating your survey of PSL Blocks 9 and 10, and the location of the B. H. Davis Survey, in Hudspeth County.

An examination of this sketch reveals that you have correctly constructed the blocks in accordance with the location of the original corners. I am filing your sketch as Hudspeth County Rolled Sketch #36; the report is designated as Hudspeth County Sketch File #33. Your location of the B. H. Davis survey from the ruins of the old Padre House and the large rock mound south of the house will place your survey in conflict with Sections 4, 9, 10, 15 and 16, PSL Block 10, Hudspeth County. The previous delineation of the B. H. Davis Survey on the El Paso County map is being corrected and our records will henceforth show the B. H. Davis Survey as lying in Hudspeth County. The Abstract of the B. H. Davis Survey will be corrected accordingly and the County Tax Assessors of El Paso and Hudspeth Counties officially notified.

Your relocation of the B. H. Davis Survey will leave a balance of Public School Land remaining in Section 23, Block 7, also in the N/2 of Section 2, T&P Ry. Co. Block 77, T. 3. If this area lies within the enclosures of the present owners of the above tracts of land, I would suggest that steps be taken to perfect their title.

Dear Mr. Carter:

In reply to your request for information relative to the correct location of the sections in PSL Blk. 10, Hudspeth County, as surveyed by A. H. Parker in 1900, I wish to advise that the following construction based on your location of the original Parker corners should be adopted.

The Parker corners located by you at the SE corner of PSL Blk. 10, the NW corner of PSL Blk. 10, and the NE corner of PSL Blk. 9, together with your relocation of the NW corner of PSL Blk. 9, from Parker's SW corner of Blk. 7 and the NE corner of Blk. 9, shall be the controlling points in a resurvey of PSL Blks. 9 and 10.

The South line of PSL Blk. 10 will run due West from the Parker SE corner to connect with a line run due South from Parker's NW corner of Blk. 10. The East lines of PSL Blks. 9 and 10 will be a line run direct from Parker's NE corner of Blk. 9 to Parker's SE corner of Blk. 10.

The West line of Blk. 9 will be a line run NE between Parker's NW corner of Blk. 10 and the corner for the NW corner of Blk. 9.

The North line of Blk. 9 is a prorated line between Parker's SW corner of 7 and Parker's NE corner of 9.

All block lines and sections shall be prorated according to the above construction.
