REPORT

Object of the Survey:

To determine the actual position on the ground, by actual survey of certain sections of land in the W.& B.B. McCutcheon pasture, and the exact location of the outside boundaries of the pasture as fixed by the lines and corners of the included sections and surveys of land.

Authority for the Survey: The request for a resurvey by the owners of lands in question to me as Licensed Land Surveyor.

Date for the Survey:

Copy of Official County Map of Jeff Davis County from the Gen. Land Office.

Working Sketch dated April 20th. 1920, from the Gen.Land Office, cov-ering T&P Blocks 55 & 56 and part of Blocks 11 and 357.

Working Sketch made by me from the fieldnotes of surveys in question from the archives of the Gen.Land Office .compared with and supplemented from the County Surveyors Records of Jeff Davis County.

Fieldnotes from Deeds to certain surveys recorded in the County Clerks Office Jeff Davis County.

Preliminary Examination of Fieldnotes:

We find Block 11 GH&SA, was surveyed originally by G.W.Angle and resurveyed in June 1889 ,at a variation of 10°10'E, for the GH&SA Ry.Co., by J.A. Greene State Surveyor, and his work approved and accepted, by other

Jun Jand Juice The N W corner of Survey 17 Block 55 and the N E corner Survey 9 Block 56 call for the McCombs Monument, North 2018 varas, this was later identified on the ground and being the only corner we could identify was made the base for our resurvey of sections in these Blocks. The still older surveys 361 and 363 GB&CNG RR. were surveyed May 1978 by Tor Mumphy and patented in September 1878

The South corner of Survey 361 was shown us . It was a very old rock mound in a flat near the bank of a creek or draw. We were told this mound had been known and recornized locally, for a

great many years as the original Murphy, South corner of 361. The public road passes north of it and its position relative to the road and creek corresponds fairly well with the fieldnotes, the old road bed is not defin -ite nor the shallow creek bed. Mr.Beau McCutcheon had known this corner for thirty years and identified it by the fact that it was near an old

and noted camping place on the creek near the old road. The appearance of the rock mound ,the position of the road and forks of the creek and the evidence of the recognition by Mr.S.A.Thompson who surveyed in 1881 and Mr.Merril, Go. Surveyor Jeff Davis Co., and Mr.McCutcheon's statement of his personal knowledge of the corner, seemed sufficient evi-

statement of his personal knowledge of the corner, seemed sufficient evi= dence to identify this rock mound as the original South Corner of 361. Survey 363 calls to be on east side of hill, S 9°E 1110 varas from South corner of 361. We found and old rock mound on the northeast slope of a steep hill, S 9°45'E 1092 varas, and a creek running along foot of hill. Block 357, Survey 12, surveyed by S.A.Thompson in August 1882, calls for a rock mound with bearings on its south line 314 varas east of its southwest corner. This mound was found in place and bearings checked 0.K., Survey 9 connects with 12.

Survey 9 connects with 12. N W survey 6 is 314 varas east of S W 9, and survey 7 joins 6 on the south. Survey 8 begins on 9 and 10 lies north of it, so that all of these surveys would seem to depend on the original S W 12, the nearest marked corner

would seem to depend on the original S W 12 ,the nearest marked corner in the Block. Block 301.surveyed by S.A. Thompson June 1881 ,calls to begin at a rock mound three feet high, N W 2 and N E 2 calls for rock mound 4' high with mountain bearings.,S E 2 calls for a rock 2' high set in ground, N W 15 calls for a rock 2 1/2' high with two mountain bearings, N W 24 calls for a rock mound 6' high with one oak bearing and a mountain peak, S W 24 calls for a rock mound 3 1/2' high with 2 oak bearings., a con-tinuous line of marked corners through the Block.,the N W corner survey 24 was found in place with oak and mountain peak bearings 0.K.. Block 337 surveyed March 1882 by S.A.Thompson . Calls to begin at the N E corner Survey 2 Block 301 and gives same bearings,runs south 1900 varad to S E 2 and gives same MARNINGE call as S E 2 Block 301. Block 11 is fixed by its own corners as above noted. South corner of Survey 414 calls for a large white oak as the corner and two oak bearings this was found all three trees marked and standing. No other marked cor-ners being called for , these four surveys will take course and distance from old oak corner, and will limit the southeast lines of Surveys 12, 13, 15 and 16 Block 301.

Block 224 ,also surveyed by Mr. Thompson, connects with the common cor-ner of Blocks 337 and 301 by the same surveyor and runs south with the west line of Block 337.

Surveys 371 and 372, sur. by Tom Murphy in 1878, have an indefinite call to begin at an unmarked mound on the south bank of Rayes Greek, from which N E 6 Fort Davis is S 25°E 3410 varas. The N E corner of 6 is itself indefinite, there is a deep rough canyon near east corner of 371 and south corner of 372, but the surface is covered with and very rough, impossible to identify an old rock mound. The fieldnotes of Survey 11 Block 224 run around 372 and can be located exactly from the Thompson corners and will rise a closer expression to the accepted location of 372 than an indefgive a closer approximation to the accepted location of 372 than an indefinite point on the bank of a rough canyon. So far we have T&P Blocks 55 and 56 with the McCombs Monument as a

beginning point no other corners found. 361 and 363 with their own corners. Block 11 GH&SA with its own corners. Block 357 ,an old corner, S W 12 ,by Thompson Block 301, 357 and 224 by Thompson.all depending on row of corners through Block 301.

Surveys 413, 414, 653 and 654 depending on the oak corner. Now we come to a group of surveys put in by , Tom Murphy, Fr.Hoban, Tayes, old co.surveyor Presidio County, and intervals filled by S.A.Thompson Surveys 831 and 832, W.J.Glenn Surveys 655 and 656, and Tom Murphy Surveys 377 and 378.

Surveys 383 and 384 by Tom Murphy in 1879, Begin at a rock mound in a Wild Rose Flat and run course and distance. We were shown a rock mound in a Wild Pose flat ,accepted and identified by Mr.Merril as the N E 383. Survey 651 ,by Hoban begins at the southwest 652 and run S 63°W 900

varas to a rock mound in a deep canyon two oak bearings. This was found and proved to be one mile S 62°W from the corner in wild rose flat. The Wild China at the N E 649 was not found, no other marked corners were called

for. These two calls locate 383,384, 649, 650, 651, and 652. Surveys 471 and 472 by Tom Murphy in 1880, call to begin on 383 and 384 and these on 65 no marked corners. But we do find an old rock mound at N E 471, run out from -Murphy corner in wild rose flat, and the point called for 455 varas N 12°E from S W corner of 471 is in creek bottom, but the creek moves over a bottom 200 to 300 varas wide, and is now on the north side. This construction from the two Murphy corners and marked Hoban corner, makes a fairly close connection by course and distance for the seven surveys in this Murphy and Hoban Block.

Surveys in this murphy and Hoban Block. Survey 65, E.S.Bibbons, of the chain of surveys on Limpia creek sur-veyed in 1874 by Tays, and calls to begin 2480 varas N 40° E from N E corner survey 11 G.Farin.

The Farin survey 11, or J.W. Magoffin survey, was put in May 1855 by Steve Archer, calls for a cottonwood for the corner , from which a cotton-wood brs N 48°W 2 varas. These trees are gone but Mabry in resurvey of H&TC Block 1 , in 1889, identifies this corner and calls for it N 79°W 453 varas from the N W 8 Block 1. So we could and did locate this point defin-

itly from the H&TC marked corners ,with bearings. This was futher confirmed by the location among young cottonwoods on the creek bed and on running N 12° E 486 varas found an old rock mound at the corner of a fence within one vara of our measurement.

This N & 11 is the point of location for S W 65 by Tays. Survey 305 surveyed 1876 by Tom Murphy S W 65 fr.wh.ME 11 brs S45°W 2475 Thence N 78° E 210 varas, 2 cottonwoods both gone , now washed away.

There are no marked corners called for in the fieldnotes of 65 and no

marked corners on the ground. The chain from N E 11 through 316, 305, and 306, all by T.O.Murphy can be run to his S W 65. But by the fieldnotes this cannot be the Tays orig-inal location of 65, Hence Surveys starting from 65 as 377, 378, 334,333, and 471 would preferably take their location by reversing the calls from the west

ras.

The actual difference is 56 varas in westing and 71 in northing, which under the conditions is really immaterial for the pasture land, and the

chain on the creek can hold their position from the N E 11. The owners of 65 have not fenced on the lines nor do they know where the actual corners are or were. They have small fields fenced on the creek but the south line and north line are both in the hills. 737 and 738 beginst the N E 11 and take course and distance.

655 and 656 are bounded by older surveys and call for them. 831 is bounded by older surveys and calls for thier corners. 832 original fieldnotes fit fairly well with the calls of adjacent surveys.

But the corrected fieldnotes by H.G.Thompson ( son of S.A.Thompson) on record at Ft.Davis and followed in fencing on the ground, lack some 109 acres of covering the land included by the original calls. The fence on the west line of 471 is 84 varas east of the line by our measurement from wild rose flat.

A fense said to be on Mr. Thompsons line from N E 333 is 10 varas north of our point , but the fence on the north line of 471 is crocked but very close to our line but stops some 275 varas short of the east line of 649. There are no marked monuments or corners on these fences. We find then McCombs corner for Block 55 and 56. Original corner in

Block 11.

Original corner for 361 and 363. Original Thompson corner for 357, 337, 301, and 224. Original corner 414 Original corner 11 - McGofflin Original N E 471 Original N E 650 Original N E 383

All surveys must depend on these corners. And the relative position of Blocks and Surveys controlled by them will depend on connections between these corners set by different surveyors at different times.

The general surface of the TERE country is mountainous, with abrupt elevations of hundreds of feet and deep canyons 100 to 500 feet deep. The only level country is the Limpia Valley, mostly in Block 11 as shown in the accompanying topographic map.

### History of the Survey

We began at the south corner of survey 361 and ran S 9°E 1070 varas and find a mound on the hillside across the creek, nothing definite, later we found the corner S 9\*45'E 1092 varas. The loose rock covered the hill side and it was difficult to find the mound.

Returning to south corner 361, we ran N 62° W and at 1800 varas reached an old rock mound at the corner of a fence, which is recognized by the owners as the end of the division line between them,

Thence N 18°E 1900 and set a mound for corner, Thence N 62°W, (the spring called for was not found), at 1511 vrs west bnk of creek, 1644 fence, 2000 in all to point for N.V.cor 362, set 5 rocks by small

of creek, 1644 fence, 2000 in all to point for N. J. cor 562, set 5 rocks by small drain, fr wh N.W.7 is N.256 & W.130 vrs, and a recent rok mnd bears N 22°25'W 350 vrs. This rok mnd is perhaps the N.E.25 resurveyed by Mr. Merril, no bearings given and no marks, so could not identify it. We returned to south cor 361 to look for Kuechler corners, ran west 1280 to a fence , course N 19°25'to corner. Going back to 1000 vara point on this line .ran south.at 784 vrs cross fence (same course on for 43 vrs then it turns S 31°50'E ) on south 1532 vrs in all to roint from which an old rok mnd hrs N 85°40'E 162, but careful search failed to find any marks on corner rooks brs N 85°40'E 162, but careful search failed to find any marks on corner rocks or any X bearings.

We again returned to South cor 301 and ran east 1017 varas and south 122 vr to a very large old rok mnd, but careful cearch failed to find any X bearings, as called for by ar Kuechler, and we could find no other mound in a radius of some 500 varas.

I enquired of adjacent land owners , who had been long resident in the country, and of Mr. Merrill Co. Sur. and could hear of no Muechler corners having been found. Consequently we had recourse to the McCombs Monument, called for

Returning to the N.E.cor sur 9,2018 vrs south of the McCombs Mon.we ran South 2018 varas and set mnd for S.E.9 & N.W.18 and took bearings, fence is 17 vrs E. Thence south at 328 vrs , set mnd on line and took brngs, on 2018 in all, set mnd for S.W.18, fr wh an old rock mnd brs North 350 and east 60 vrs , no marks,

mnd for S.W.18,17 wh an old rock that bre worth bac and east be vis the marks, no X bearings and no other mnd near by fence cor N.19 & E.28. Thence South 1400 vrs to pt for S.E.21 set mnd. Thence South 1008 vrs and West 70 varas to N.W.cor sur 161 Blk 11.This cor is in a small flat ,north of road and creek.The mnd is not large but the mkd rock is a large boulder.Marks plain but old.Both bearings 0.K.at Var.11°05'E. The N.E. bearing is not very definite , two possible points on ridge to fit description. The old mnd called for N 30°25'E 527 was not found, but Mr.McCutch eon stated that he had seen it on the ridge where the call would place it. From this well identified N.W.cor 161 we ran S 85°25'W 754 varas to a large

old mnd near top of very steep rough rocky ridge, shown us as the S.E.cor sur 363, as recognized (or set)by S.A.Thompson and accepted by Mr.Merrill, who makes the distance 764, due perhaps to chaining over rough slope. We read distance direct from corner to corner and then ran west 751 and north 61 to corner. Thence we ran 8 81°W 1900 varas, over a cliff some 250 'high and along the north slope of a ridge, to a point 30 vrs west of a fence corner and set mnd for S.W. 363. Thence North 9°W 1906 varas to an old rock mnd set on the east slope of a

steep hill, creek about 100 vrs east, and the old mnd at south cor 361 N 9º 45'W 1092 vrs. This mnd on the hill side is the one we missed on our preliminary run S 10°E from 361, as above noted. It is evidently a corner, artificial not natural and appears to be old enough for the original Tom Murphy corner, and is fairly

close to call allowing for the chaining up the slope. This places N.W.cor 161, South 2600 vrs and East 3111 vrs from S.E.361. We returned to N.W.161 and ran a tryerse along the road to South cor 361, which placed N.W.161, south 2626 vrs and East 3088 vrs. The figure for the trverse are attached to this report. The difference in resultants is probably due to the fact that the latter run was completed in a heavy rain, as it was only a check we did not take time to rerun it.

We now went to the south line of sur 12 Blk 357, and were shown Thompsons corner set 314 varas east of S.W.12. and identified it by its bearings. We ran west 314 varas and set mnd for S.W.12 and took bearings. Thence ran east 1900 varas to a point in draw, on east side of a drain for S.E.12.made mnd.Thence ran a tryerse to the S.W.cor sur 363, finding it 1114 north and 625 west. This survey shows that we did not find any Kuechler corners but started at

the McCombs corner.

That we did find what seemed to us to be the original corners of 361 & 363 and found original S.W.12, these corners with the lines of connection run set-tle the location of surveys in these blocks and their relative position on the ground.

We now returned to the S.W.18 as above described and ran east 1900 and set mnd for S.E.18. Thence North at 608 set mnd on line, on 1009 to the middle point of west line of sur 15 and set mnd for the N.W.cor S 1/2 sur 15.

We ran the middle line of these surveys as it was the line of the McCutheon pasture.

Thence East , over a sharp pinacle, on across valley , 1900 varas set mnd for N.E.cor S 1/2 15, took bearings , fence 40 vrs south.

Thence ran east 1900 vrs , made mnd and took bearings for N.E.cor S 1/2 sur 14.0n east 1900 vrs made mnd and bearings for N.E.cor S 1/2 13, fence cor South 42, west 75 vrs.

Thence South 1009 varas made mnd and took brngs for the S.E.cor sur 13, fence South 33, west 75.

We were on the north edge of a deep canyon which could be crossed at only one trail, so we did not run the north line of 21 along and in this canyon, but ran a traverse 1400 vrs south and 1835 vrs east to a point 7.5 vrs west of a fence corner and 5 vrs west of a rock mnd, on east 65 vrs set mnd for S.E.21.

To check, we went south to the S.W.cor sur 166 Blk 11, which we identified by marked mnd and bearings as called for , and ran north at 11°05'E var. At 2043 vrs pass 19 vrs east of a large rok mnd, unmarked, but the one Mt. brg given at N.W.166 fits, on 469 vrs pass over an old rok mnd mkd "N.E.202" on 600 varas 1069 in all to the rock mnd above mentioned 2.5 west of fence corner,for N.W.201 60 varas west of our S.E cor 21. From this N.W.201 ran east 1900 vrs and made mnd for N.E.201

Thence South at 1062 vrs reach a point in a canyon 1 vara east of a rok mnd, set mnd for S.E.201. Thence east 1900 vrs made mnd and mkd bearing for N.E.167.

Thence South (11°05'E) at 2040 varas reach an old rock mnd under a fence, mkd "N.E.154"Boulder mkd X N 18°W 1 vra, Mt.brngs as called for in Greene's resurvey field notes for sur 154 Blk 11.

On south ,at 1902 vrs reach old mnd under a fence , bearings O.K.live oak

still standing but partly dead. On south at 1900 varas reach rck mnd near foot of steep south slope of a rocky hill. No marked rock found, but bearings fit for calls at N.E 108. Marked new rock.

Thence West 1900 vrs set mnd for N.W. 108, on east slope of a ridge. Thence south 1900 varas set mnd in valley for N.E.74.

Thence south , at 1927 varas we reached an old rok mnd on south side of the

Thence south , at 1927 varas we reached an old rek mnd on acuth side of the Stockton road, bearings fit calls for N.E.63.We went one mile east to the N.E. cor 62 and found it as described in the field notes ,which state that it is an original Archer corner.We set a flar at this N.E.62,which could be seen from N.E.63, and gave us a reading of East at a var of 11°06' by our needle. Thence South 1900 vrs set mnd on low ridge for S.E.63 and took brngs. Thence West , over very rough steer hills , and across a deep canyon.1800 vrs to a point on south side of canyon 17 vrs north of an old rock mnd mkd "N.E.28", this mnd was east of a boulder some 12' high on which an X is cut S 79° 15'W 10 varas., and we could see the two windmills at the Jeff NcCutcheon Ranch, one of which bears N 88° 40'E. which bears N 88º 40'E.

The marking on the rock was old and moss covered, the mound was made of lag rocks and partly covered with brush. The X looked much fresher than the marks on the rock, but it was protected from the weather by the overhanging rock. Mr. McElroy, the manager of the Jeff Ranch said he and Mr. Merril had hunted half a day for this corner without finding it, hence the corner could not have been well known and probably has not been interfored with, though the X at first looked doubtful as to age. I believe this is the original Freene corner.

On west over a rough ridge and into a small valley 1900 varas, made rok mnd on small nose for N.E.27 and took bearings.

On west along rough slope of ridre ,across deep canyon ,and on top of the bluff of rim rock, 1900 varas to a point 14.6 north of N.E.26 and 112.5 north of witness mound marked as called for at this corner 127 varas south.

From this point on bluff we ran a traverse on top of mountain to locate the rim or bluff which forms the practical boudary between the range on top and that in the valley, and also locate the lines and corners of the surveys.

The details of this traverse are attached to this report. It shows that we ran to a point 1900 varas south and 1900 varas west and made mnd for the E.E. sur 25, and on 1900 varas west and 2438 varas south putting in S.W.22. cor

Thence West at 860 bluff, 1432 point in Limpia Canyon, on east side of the creek, thence west 468 varas 1990 in all to a point 42 varas east and 23 north of the witness mnd called for at this corner. This witness mnd is near the top of a slope so steep that one has to crawl up it, the corner should be N45° E 80. Our line would come out 19 varas south. From this point 468 varas east of S.W.23 we ran a traverse up the creek

through Limpia canyon to a large rock mound in Wild Rose flat, which showed it to be 1405 south and 1079 varas west of S.W.23. This mound is on the showed it of the public road and west of the creek, from it Edge of perpendicular bluff bears N 11°W about 250 vrs, and North edge of cliff bears N 59° 30'E about 950 vrs, which are the bearings given by Mr. Merrill for the rock mound in Wild Rose flat which he accepted as the original N.E.cor sur 383, and on which he bases his resurvey of sur 29 M.K.& T.E.

From this rock mound we took a bearing on a boulder at foot of bluff on north end of ridge and made a triangle which places the boulder N 59° 25'E 1031 varas from the rock mound. This same boulder is S 14° E from the third station on our trverse up the canyon.

This traverse showed so serious a difference between our run and Mr. Merril figures, that we decided to check on it by running from the original N.W.cor 22 Blk 11,a well known corner ,near Mr.B.McCutcheons house.

We went to this corner , the call for the sprine fits, but the tree is gone, and ran a tryerse along the road from the house to the public road and along that road to the Wild Rose flat, as a line on this route was easier to run, and less subject to error than a line across a very rough and broken country

The details are given below. The traverse shows that Syly25xis N.W.22 is 3839 nouth and 2978 west of N.E. 383.0r from S.W. 83, 3830- 2438 =1401 south and 2978-1900=1078 west to N.E.383.

This rock mound for N.E.323 is between the cree: and the road, it was set by Murphy in 1878, was in a public place, along the road and bence likely to be known and was easily reached. Fr. Hoban who put in 649-50-50 & 652 ways he wonneuted with this corner and marked a corner in a deep canyon a mile S C3º E.W

We ran from this N.E.363 5 C20 W 1800 varas to an old rock mud in Fraziur canyon on south side of road and creek. This mound is old, is artificial not natural. The moss on the rocks show that they have lain long unmoved, and grass and small brush grow in and round the rocks. From this mound an oak tree plainly marked with an X and hacks (old marks) stands S 53° E 18 wrs and a stump of an other large oak is S 70° W 35 varas right in distance but the course in the field note call is S 63° W. This seemed to us to be the original Hoban corner and to further identify the mound in Wild Rose flat as the original N.F. 383. Returning to this N.E. 383, we ran S 27° E1900 vrs and l set mnd

for S.E. 385, on 1900 varas set corner for S.E. 384 and N.E. 647. and took bearings.

Thence south 12° E across a draw, at 682 wrs we sat a mod in live oak grove at foot of steep rock capped ridge, and marked bearings for N.W.648. On S12°E over the ridge and valley, over another ridge into a draw, 1900 varias to a point on the south bluff of creek bank. We could not set and at this point, but set witness and and mkd bearing on bluff, for S.E.647. Thence Wints 5 78°W, over a very rough ridge and across canvon, 1304 varias

to a point on west side canyon, under an overhanding houlder, set and for S.W. 5 647, and marked bearing for S. J. 647.

Dear Sir, I am sending you under another cover a prliminary report on a survey of certain tracts of land in Jeff Davis Co.embraced in the W.W.& B.B.McCutche on Pasture.

These tracts are parts of Blocks which were surveyed originally by dif-ferent surveyors , and at different times. They call to join, but on the ground we find considerable differences in course and distance between old corners and the field note calls. This calls for correction in field notes of a number of surveys dependent on the construction of these various blocks under their field notes and the facts found on the ground.

field notes and the facts found on the ground. The object of this survey was to find the facts so that a correct recon-struction of surveys could be made. I would like to have you kindly examine the Plat and field notes and in-struct me as to any changes or alterations that should be made, so that I can make out corrected field notes for surveys altered by the facts found. The report is written as a full statement of the survey made, but in ad-dition to the position of corners and survey lines I have introduced, for the convenience of the owners the location of fences, bluffe and other natural ob-jects which have no direct relation to the lines of surveys and are immaterial so far as reconstruction of Blocks is concerned, but introducing them in this report avoided making another report on these facts of vital importance to owners. This will explain the introduction of unessential data, and the method of presenting some of the facts. I will probably have time to go over the matter when I come to Austin on my way to Starr Co.work.

From S.W.471 we ran N 12° W, at 469 varas reached the creek bottom, which is some 300 varas wide, the present channel being on the north side, a low gravel island in the middle and an old chanel on the south side near our point. The original call for 471 places the creek 455 yrs N 12° 7 from S.W. 471. Running on N 12°W 355 vrs ,826 in all brings us to the top of low ridge on north side of creek valley ten varas south of a fence said to be on Thompsons north line 333 which calls to start at S.E.cor sur 65 and reach west line 471, 825 varas N12°E from S.W.corner. On N 12°W crossing another fence 1074 varas, 1900 varas in all, made mnd and brngs for N.W.471, fonce cor east 84, N 13 varas.

Thence N 78°E , at 582 fence on line, at about 1100 fence about 75 north. at 1377 varas in all made mnd for S.E.832 at inter section with wbl 649, on N 78° W 533 large old mnd, probably Murphys N.E.471. The location of this old mnd on the bluff north of the creek and the bluff south, correspond with description in the field notes of 471.

Returning to our S.E.832 , we ran N 12° W 1760 varas to a point on very steep slope of high ridge about 300 varas south of foot of ridge bluff, made mnd and X brng for corner , on N 12°W themax 120, then N78°E 20 vrs set mnd for S.E.831, near foot of ridge bluff.

Thence S 78° W, at 176 varas top of bluff (elevation angle 22°), on S 78° W over mesa, at 804 edge of mesa, on across valley 1670 varas in all made mnd and mkd brngs for N.W.832, fence corner South 51 & East66 varas, said to be H.G. Thompsons N.W.832.

Thence N. 12° W at 513 edge of bluff, on 910 varas in all made rock mnd for N.E. 378.

Before finally setting these corners we went to the original south corner of sur 414. We found a white oak some 3' in dia marked X on two sides, the limbs had been cut off but the tree was alive and sprouting new branches, both bearings were found, the N.W. tree plainly marked and standing as called for, but the other, also plainly marked stood S 79° E 64 vrs , not S 30° E 60, as called for should be \$ 30°E in the copy of field notes I had.

From this corner we ran N 45°E and at 593 varas reached our west line of 378,114 varas from its N.W.corner, and on 210 varas crossed the north line of 378,178 varas from its N.W.corner.

From our corner at the intersection of S.E.line 414 and west line 378, we ran S 12°E at 750 reach top of bluff, on at 1723 reach north side of impassable canyon. (I timed the front rodman riding round to where he could cross to the point opposite us, and it took 47 minutes) I mention this to show the character of country over which these old surveys were located as it suggests a reason for some of the errors and conflicts we found)

At 2324 point across canyon on ridge. The S.W. cor 378 will fall in the canyon. On at 2526 south bluff of ridge and at 2807 we reached the north line of survey 65 Emory Gibbons, 62 varas west of its N.E.corner as located by the Murphy calls from N.E.11.0n to point 3800 varas S 12°E from our N.W.378 or 3686 from the intersection corner on west line 378, we reach a point 71 varas north and 56 west of a rock mnd said to be the S.E.cor sur 65.

As noted above in discussing field notes, Surveys 377, 378, 334, 333, 471, 472 call to start or connect with Sur 65, but it was also noted that the calls by Tays original surveyor of 65 were in contradiction to the calls of surveys made later by Murphy between S.W. 65 and N.E. 11.

We searched carefully for any original marks or corners on sur 65 but did not find any, and enquired of residents and could hear of none. Ed Dutchover who owns part of 65 and lives near by showed us a rock mound he said he thought had been placed by some surveyor for \$.E.65, but he was not sure of the mound as there were four near by. The north and south lines of 65 lie in the rough, so no one is particularly interested in them, consequently their location has been

forgotten if ever marked. It is impossible to locate 65 by its own corners or marks on the ground, and we could find no local witnesses, and the calls for other surveys are so contradictory that it seemed hopeless to try to start from a corner of 65 or to attempt to locate surveys by it, hence we reversed the calls and ran from the definite connections on the east as related above.

However to test the matter we traced the Murphy calls from N.E.11.

The N.E.cor sur 11, G.Tarin, or as locally known the McGlofflin survey, is described as a 3'cottonwood with a cottonwood bearing. Mr Murphy calls for this corner but when he put in 316 he says only the stump was left. All large trees have disappeared from the place where this corner stood. But when Mabry made his resurvey of Blk 1 H.& T.C. he was able to identify it and calls for it at the N.W.cor sur vey 8 H.& T.C. Blk 1 as N 79°W 456 varas.

We went to the S.W.cor sur 8, a rock mnd under a fence and identified by its bearings, and ran North 1900 varas to a large rock mound on a bill identified by its bearings as N.W.sur 8, and ran thence N 79° W 45G varas and reached a point in the gravel bed of the creek, nothing but young cottonwoods any where near. Thence we ran N 12°W 486 to a fence corner and N 78°E 103 to a rock mnd set for South corner sur 656. (noted needle 20'off) on 540 in all to large rock on south side of road ,2 varas from fence. Monument bears N 47º 20'E (needle 49º ) Thence N 12° W 454 to N.W. 306 (Mon N 52° 40'E Needle 53° 10')

Thence N 78°E 950 to point in the road near gate for N.E. 306,

I gave the readings of the needle along this run as I thought it possible that it might help to account for the contradiction in calls between Tays and Murphy.

We returned to S.E.65 above described and ran east 210 varas to look for the bearings Mr. Murphy calls for at M. B. 305, but the creek has washed through there and left nothing , cutting into the bank so as to leave the surface 12'

above the bed of the creek. These small surveys are not fenced on the survey lines , except in places, and the original lines are not held, as owners have sold and traded so as to divide the land to the best advantage for use of the tillable land and convenience. We had no intention of officially resurveying these tracts or in any way passing on their position and corners , we were simply trying to re-trace the original calls in order to settle a starting point on sur 65 if possible.

The result was, as stated above , that we abandonned the call for 65 as absolutely indeterminate under the facts as we found them.

Survey 737 begins at N.E.11, and survey 738 begins on 737 and we wanted the south line of sur 738.

We also wanted a division line through 656 under the callings of a deed from Mr. Ward to W.& B.B.McCutcheon. The actual location of this division line was evidenced on the ground by a fence N 67°W 1340 vrs by the deed, from a fence post on the road, from which fance post it ran also N 21° E 234 vrs to a point in thewest line of sur 65 297 waras from its S.W.corner.

To retrace these calls we went to our S.W.cor 65 and ran N 12° W 297 & made mnd, but to reach the next call we had to run N 67° W 71 varas to a post Thence with calls, S 22° W 234 along road to post at and of fence, thence N 67° W 1340 to point on hill, thence west 202 varas to east line sur 738 ,2238 varas

north from N.E.11. We marked this point, but could not run south to S.E. 738 on account of the bluff, so we ran S 33° W 404 vrs to point in south line sur 738 and mkd it 219.5 varas westof S.E.corner.

Thence we ran west 1680.5, 1900 in all to a point on west slope of draw, and made and marked rock mnd and took bearings for the S.W.cor sur 738.

This completed the survey of lands and lines in question which depended on , or were connected with survey 11 or sur 65.

The adjacent surveys 97,98,99, in Blk 224 depended for their location on the Thompson corners which are called for on the meridian through B1% 298 301 as noted above. So we moved there.

As it was necessary to connect the Thompson corners with sur 413 & 214, we returned to the south corner of sur 414 above described, and reran , as a check, from this corner N 45°E 593, to correr on 210 to corner, and then made a traverse to a point near the middle of sur 653 and on east 1033, to point for east cor 653 by course and distance from original south cor 414.

From this east cor 653 we ran east 2889 and at 116 north reached the old . N.E.650 in Frazier canyon above described.

we ran north and put in the north cor 653 point of traverse Returning to and later connected this with S.E.14 west 643 varas and north 148 varas.

From this point we ran a traverse north to a bluff at a point which we figured from map and field note calls , should be 310 south and 97 east of S.W.24 and went below the bluff to look for it.

Along the foot of the bluff there runs a dry creek bed , and along it some scatered stumps of oaks with branches trimmed off , and a few whole trees. Near the creek on the north side we found a large old rock mnd, but the

near by oaks would fit neither course , distance nor description, one being called a "red oak" while all near by trees or stumps were white oak. This differ-

in description would seem unimportant, but locally it is as important as the difference between an oak and a cedar, so that the distinction made in the field notes is noteworthy.

We found two other mnds to S.E. which lined up with the mnd across the creek, which suggested old fence line. Present fence crosses some 200 varas fut ther down the draw.

We found another mnd N.W. of the first on a small ridge, but no trees near. We then searched the trees for marks but found none. The bark or some of the stumpd had fallen off. We could find only one place where ared oak and white oak stood nearly in proper position to one another , and neither of these was marked.

Not finding this corner we went a mile north and where a few large lone oaks stood on a mesa at foot of high ridge.Here we found a mound built of flat rock, some 4' high, and from it a peculiar rock capped peak bore as called for and on running S 36°30'E 406 vrs we reached a large forked white oak plainly marked, (old marks).

We placed a flag on this corner N.W.24 Blk 301 and returning to our point on the bluff found flag to bear N 1°35'E, instead of west as figured.
