WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT I J. W. Espy of the county of Jeff Davis, State of Texas, for and in consideration of the sum of ten (\$10.00) dollars and other good and valuable consideration to me in hand paid by the State of Texas, the receipt whereof is hereby acknowledged and confessed, granted, sold, and conveyed, and by these presents do grant, sell, and convey unto the said State of Texas all that certain tract of land in Jeff Davis County, Texas, out of Survey 1300 and 734-B described as follows, to wit:

Beginning at the original southwest corner of survey 308, a rock mound located 25 feet south from the center line of the Scenic State Highway just east of what is known as Picnic Rocks, located 2½ miles on said Highway from the town of Fort Davis; thence in a southerly direction, S 6 degrees W., for a distance of 1916.6 feet 65 to a stone monument. Thence in a northerly direction, N 84 degrees W., for a distance of 2640 feet to a stone monument. Thence in a southerly direction, S 6 degrees W., for a distance of 2500 feet to a stone monument. Thence in a northerly direction, N 52 degrees 30' E., for a distance of 3640 feet to a stone monument. Thence in a southerly direction, S 84 degrees E., for a distance of 2640 feet to a stone monument. Thence in a northerly direction, N 6 degrees E, for a distance of 1916.6 feet to a stone monument, said monument being the southeast corner of section 308. Thence in a northerly direction N 84 degrees W., for a distance of 2640 feet to a stone monument, said monument being the southeast corner of section 308. Thence in a northerly direction N 84 degrees W., for a distance of 2640 feet to a stone monument, said monument being the point of beginning of the above stated survey, containing 169 acres more or less.

This conveyance is made as a donation of land for the use of the people of Texas, for camping accommocations and for Park purposes, and is made with the express covenant and condition that the State of Texas reserves the right at any time to fence said above described lands, and that such fencing shall be located so that it will not cut off the movement of sheep or cattle throught said area. And the grantor herein now represents that no part of said lands above described constitute a homestead or any part thereof.

Session to be maintained under regulations similar to those imposed by the United States Government in National Parks and whenever the lands herein described shall cease to be used or maintained for use by the State for such camping accommodations and for Park purposes, the Title thereto shall revert to the grantor or his heirs, successiors or assigns.

TO HAVE AND TO HOLD the above described premises together with all and singular the rights and appurtenances thereto in anywise belonging unto the said State of Texas and its assigns forever, and I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said State of Texas and its assigns against every person whomsoever lawfully claiming or to claim the same or any part thereof.
