Thence South at 914 varas cross the track of said railway; course S 30° 30' W; at 1902 varas a stake for the south east corner of said Section 22; the S.W. Corner of Section 23;

Thence West 950 varas to a stake for corner of this tract.

Thence North at 250 varas cross the track of said railway; course not taken; but approximately S 64° 30' W.; at 1902 varas the north line of said Section 22 and the south line of Section 15.

Thence East 950 varas to the beginning.

Containing 320 acres of land, inclusive of 16 acres of right of way of said Railway Company.

The variation used in running these lines was 11° 30' E.
