Report of D. H. Barnes Survey No. 2 Out of the Nancy H. Grimes Survey No. 2 Jefferson County, Texas

Re: File 59342

I respectfully submit the following report of a survey of 533.11 acres of land out of Mrs. Nancy H. Grimes' Survey No. 2 on Taylors and Hillebrandts Bayous and situated in Jefferson County, Texas; made for the Heirs of D. H. Barnes by virtue of their desire to complete the purchase of said land.

On February 20th, 1935, I made a survey of the D. H. Barnes Survey No. 1 out of the Nancy H. Grimes Southwest corner of Survey No. 2, and made for Mrs. George W. White of Beaumont, and on February 25th, 1935, I made a report to Mr. J. H. Walker, then Commissioner of the General Land Office, covering my investigation of this survey. Said report explains in detail the method in which I surveyed the meander lines of the Nancy H. Grimes Survey No. 2, which borders along the J. J. French League and which was resurveyed by Mr. L. J. Kopke in 1931. I resurveyed the meander lines along the J. J. French Survey on May 13th, 1940 and found the corners and lines to be the same as found in 1935.

The William Murphy Survey, to the West of the Nancy Grimes Survey No. 2, was originally surveyed by Jim Ingalls in 1863, in which he found its East line to be 1619 varas. Mr. W. O. Work, a Licensed State Surveyor, made a private survey of the William Murphy Survey in 1927, and found its East line to be 628.56 varas, while I found it to be 631.2 varas.

Mr. A. B. Doucette, when County Surveyor of Jefferson County, on February 3rd, 1901, made a survey of the C. L. Carlson (T. L. Wren) Survey of 22 acres on Hillebrandts Bayou and located North of the William Murphy Survey, found the East line of same to be 71 varas, while I found it to be 103 varas. I found the Northeast corner of the William Murphy Survey marked by an iron pipe by the side of a 4x4 wooden stake with a wire fence built on the East line of the Carlson Survey and along the East line of the Murphy Survey, with the exception that at a point near the Murphy Southeast corner the fence bears 1 wara to the East on the Nancy H. Grimes Survey. I found a fence on the West line of the Murphy Survey and found the South line of the Murphy to be 407 waras as called for in its original field notes.

Mr. Jim Ingalls, on March 28th, 1885, made the original survey of the Nancy H. Grimes Survey No. 2 as recorded in Vol. F, Page 199, County Sur-veyor's Records, in which he found the survey to contain 5752 acres, with the West line of said survey being 620 varas and follows the calls of the Blackman and French Surveys according to their original field notes.

Mr. George W. White, on July 6th, 1920, made a resurvey of the said Grimes Survey No. 2 as reflected in Vol F, Page 292, County Surveyor's Records of Jefferson County, in which he found 674 acres of land and found that the West line of the said Grimes Survey was 1037 varas. He likewise follows the original meander lines of the Blackman and French meanders and generally follows the calls and distances as given by Jim Ingalls along Terlors and Hillebrandts Bayou with several exceptions, in which he uses Taylors and Hillebrandts Bayou with several exceptions, in which he uses the same course but uses a longer distance.

On My survey made May 13th, 1940, I found that the total acreage of the Nancy H. Grimes Survey No. 2 contains 570.21 acres of land, of which 37.1 acres is occupied by the D. H. Barnes Survey No. 1 and owned by Mrs. George W. White, and 533.11 acres of land covered by the D. H. Barnes Survey No. 2. I found that the line of the Grimes Survey, where it adjoins the Carlson and Murphy Surveys, to have a length of 734.2 varas against Ingalls survey of 620 varas and of White's survey of 1037 varas. I also found that the distance along the Grimes Survey line which borders on the North line of the Bennett Blackman Survey to be 395.6 varas, against the original field notes call of 397 varas. I did not find any evidence along Hillebrandts and Taylors Bayou to indicate that it had ever been either Hillebrandts and Taylors Bayou to indicate that it had ever been either widened or filled in.
