Dear Sir:

The following is a statement of the line run by me, and what I found upon the ground on "S. B. Burnett's King County Ranch" Thursday Oct. 16th 1902.

I commenced at the S. E. Corner of No. 53 B. S. & F. Survey Blk.3, a large Md of stone in valley of branch. Co. S. W. a 12 in. Hac.(original bearing) brs. N. 10 W. 8 vs. using a var of 10'10'E. Thence W. at 1600 vs crossed a br. Co.S., GnL. Co. S. E., in all 1950 vrs to a point 51 vrs. S. of S. W. Cor. of said survey No.53. Thence N. 51 vrs. to said S. W. Cor. of No.53 a md. of stone for corner.

Thence W. at 500 vs. Br. Co S. E. at -----vs. another Br. in all 1945 vs. to a point 45 vs. S. of S. W. Cor. of No.51 B. S. & F. Blk.3,. Said Cor being md of stone, "marked an 8" Hac. standing 4 vs N. E. of same.

Thence from said Cor. N. 89 W. at 912 vs. small br. (Co. S. W.) at 1880 varas another br. Co.S.W. in all 1944 vs to a point 24 vs S. of the S. E. Cor of No.50 B. S. & F. a large Md. of stone for said Cor.

Thence from said stone md. N. 88 1/2 W. 1931 vrs to a point in prairie, whence a mesk. stump brs. W. 12 vs and a group of china trees brs. N.39 E. from 300 to 500 vrs. distant (guessed).

Thence N. 88 1/2 W. at 700 vs. E. edge of dry pond or lake, at 900 vrs. the W. edge of same, whence 2 peaks brs. N. 28 3/4 W. in all 1900 to point in large valley in Pr., no cor. found.

Thence N. 88 1/2 W. at passed between two china groves in a draw or sink hole, in all 1981 vs. to a point 7 vs. S. of a md. of stone in a draw, for S. W. Cor. of No.46 & S. E. Cor. of No.45 B. S. &. F. Blk.3.

(call to be N. 19 1/2 E. in original field notes) Same difference of bearing **ås** found upon the E. & W. line of this Block.

Thence N. at 50 vs. Crossing sd. Arroa, at 370 vs. Crossing br. (Co. S.E.) at 470 vs. small drain Co. S.W. at 1350 Br.near head (Co. S.E.) at 1560 vs. tops of Ridge dividing waters of Brazos & Red Rivers, in all 1900 to a point on S. E. bank of a br.(Co.N.E. for about 100 vs. to where it changes its course to a little E.of N. for about 700 vs)at 700 vs. a br. (Co. E.) at 1900 vrs crossed the many heads of a deep Arroa (Co. Thence N. 88 1/2 W. at 400 vs creek (Co N. W.) at 930 vs. br. (Wo. N.) in all 1900 vrs to pond on W. side of a hill, no cor found. Monday Oct. 20th 1902.

Set compass on "N.M." stone as set up by U.S.C.&G. survey in Guthrie, the CO/Site of King Co. and took a sight to a point in "S M"stone, as set up by sd.C. & G. surveyors, and found the variation according to sd monuments to be 10 52 E.

On date last above written, commenced at the N. W. Cor of Sur. No.1, B. B. B. & C. R. R. Co.(the survey upon which Guthrie is located) a large md. of stone for Cor. in S. line of Deby Morris survey 605 vs. W. of its S. E. Cor. a cedar stump (Orig Br'ng) brs. S. 17 E? 25 vs.
