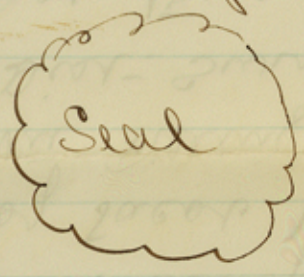

the map of Kinney County.



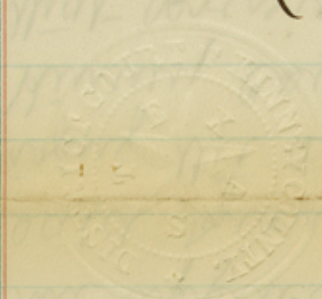
