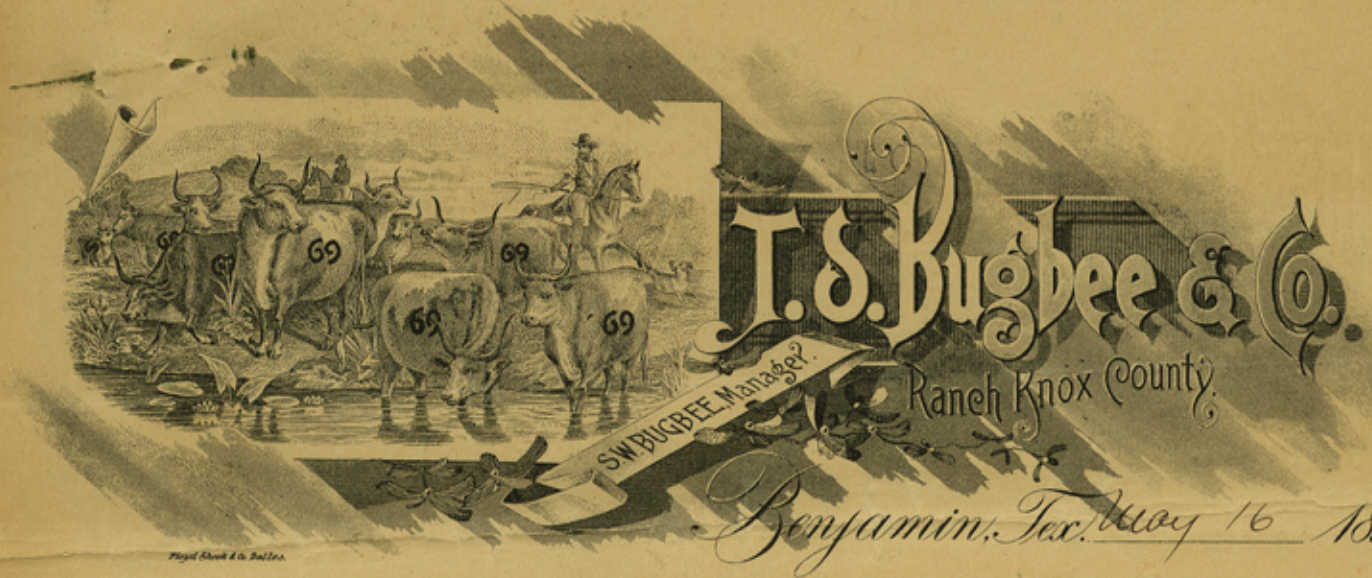

 and settlers of Knox county respectfully submit,
 that they now hold as actual settlers either
 in their own right as first purchasers or as
 the assignees of such first purchasers public
 school lands in Knox county in Block 45
 H.S.D. C. R. R. Co. which has been recently ad-
 judged to the D. H. R. R. Co. in the suit which
 has long been pending. We have been waiting
 for a long time for the settlement of this question,
 and while we have full confidence in your abil-
 ity and desire to protect our rights, yet we and
 disinterested have the matter settled at as early a
 day as possible. We learn from letters from your
 department, and from Mr. Mabry that you have
 refused to approve the field notes of the ~~Public~~ ^{D. H. R. R.}
 lands made by G. L. Brown Surveyor of Knox county
 Mr. Mabry, and that your refusal is probably now
 caused by your desire to protect our interest.

We do not desire to have our interest in any
 way interfere with a speedy settlement of the ques-
 tion according to law, and we therefore request you
 to approve the field notes of the said D. H. R. R. lands
 and to award us our lands under said survey.
