The Connection of the surveys of Robert Burrell and Joshua May's field notes as given by the Surveyor placed these two and consequently all north of them 1460 varas too far north on the Ground. Their connections being run from a Point 1460 varas South of the place where the S.E. corner of the Dever Survey appears on the map.

The correction of this error in the sketch
counter 29962

herewith forwarded consequently makes a
conflict with two of the Surveys for the
Houston Tap and Brazoria R.R. Co. returned
by myself, on the East lines of the Devore
Lynch Parish & Whitington Surveys.

The call of the S.S. McKinney Survey to begin on
the East line of the John Darling Survey,
was evidently false, as the same Surveyor
afterwards returned a sketch corresponding with
this, placing McKinney in conflict with Darling
by the sketch at least 500 varas, by the collision

In the Delgado and Newby field notes
the Surveyor calls for the Lines of Denton & Young's
Surveys. This will be ascertained by actual Survey
as soon as the owners of these claims furnish
fund to cover fees for the work.
