In the location of this survey I have accepted the work of H.Jackson Co.Surveyor of Liberty Co. in 1847 whose certificate will be found in the field notes of the Alfred Lane survey now abandoned. The original location of Lane was made in 1835 but conflicted with the T.J. Haggerty & was resurveyed in 1847 correcting said conflict with the Haggerty since which date the Land Office map and the work of subsequent county surveyors have recognized the Haggerty league as occupying the position given it by me. The S.W.corner of the Haggerty falls in a large open prairie where the nearest timber or island of timber is 3 miles to the N.W. of it.

This survey known as Hickrey Island League is located independent of other surveys its field notes calling for no connection with any other surveys. It was located to take in a large island of timber, its field notes call to begin at a stake at the Southwest

point of Hickory Island whence a Pecan 15 dia brs N.58 E.231 vrs & a Dox 15" dia. & forked brs N.59 E. 230 vrs. Thence N.85 E. 4000 vrs etc. I found three old corners in the timbers of Hickrey Island & 2 old lines hacked through the timber but none of them bore original marks. The corners thus found were all in the timber of the island and were evidently none of them near the orig. position of said corner. For the field notes call the brg tree to be 230 vrs distant, the S.W. pt. of Hickory Island timber is clearly & sharply defined; no surveyor could fail to locate this point with accuracy and precision at this extreme S.W.point of the island stands a bitter pecan tree 18 dia & forked, thus fitting the description of the tree given in the field notes. No marks however can be found upon it. This is easily explained by the fact that the pecan sheds its bark and consequently it would not retain a mark many years. I accepted this tree as the brg tree called for in field notes and located the corner 230 vrs. S.59 W. from it set a cedar post 6 dia for a corner from which another pecan 18 dia brs N.58 1/2 E. 231 vrs. & a dble ash 7 dia brs. N.83 3/4 E. 221 brs. an old corner inthe timber of island brs. N.61 3/4 E. 270 1/2 vrs. & an old hacked line (running in 85 E) is North of my corner 438 vrs. This line excludes from the survey abt 400 vrs of the island of timber which the sur. was evidently intended to include.
