of Live Oak County do hereby certify that by an actual & careful survey on the ground made by me personally, I did find on the ground the courses & distances as set forth in the field notes given below concerning the relative position on the ground of surveys in name of Maria Brennon, J. H. Gibson No. 310. J. Poitevent survey No. 312. and Bealy Seale & Donwood survey No. 207, and also John Ward survey No. 333. That I began at the lower corner of Patrick McGloin's Grant & the upper corner of Maria Brennon's Grant: on the East bank of the Neeces River at the mouth of a small gully at a tree marked with old marks & which was pointed out to me by Mr. O'Haley a colonist of Mr. Mullen & Mr. Gloin's Colony. at the corner above described, Thence $N 39^{\circ} E$ with the dividing line of said two grants at 6600 varas passed the N. E. corner of said Patrick McGloin's Grant & the S. E. corner of a survey in name of John Geraghty of one third league (1476 acres) and continued same course with the dividing line of said Geraghty survey & said Brennon Grant. at 8276 varas to a stake & a live oak with old marks which is known to be the North corner of said Brennon Grant. & more recently made the west corner of J. Poitevent survey No. 312. Thence $S 13\frac{1}{2}^{\circ} E$ with the Eastern line of said Brennon Grant & western lines of

of said Poterent survey N^o 312. and J. H. Gibson survey N^o 310. and while running said line I found four very large old Mesquite trees which are marked as line marks with very old marks - evidently done at the time of making said Brennon survey. following the line aforesaid at 2821 varas to a stake the S. W. corner of said J. H. Gibson survey N^o 310. from which a Live oak Mk^o X br^o N 35° W 14 varas another Live oak Mk^o I br^o S 19° E 33 varas Thence N 76½° E. 1002 varas the N. W. corner of John Ward survey N^o 333 of 132½ acres Thence S 13½° E 200 varas a stake the N. W. corner of Bealy, Seal & Fomrod survey N^o 209. from which a Live oak Mk^o X br^o N 8° W 34 varas another L. O. Mk^o V br^o N 61° W 50 varas Thence N 76½° E crossing Lapara creek at 1600 varas a stake the N. E. corner of said survey N^o 209. Thence S 13½° E at 1308 varas a stake the N. W. corner of Bealy - Seal & Fomrod survey N^o 210. Thence N 76½° E with the Northern line of said B. S. & F. Sur. N^o 210 at 284 varas to a stake intersected the western line of E. Garner's Sur. of 640 acres. Thence with the western line of said Garner's survey N 13½° W at 1508 varas a stake the S. E. corner of said Gibson's survey N^o 309. from which a mesq^t. Mk^o X br^o S 37° W 30 varas which being also the N. E. corner of said Ward survey N^o 333.

I further certify that the foregoing Field Notes contain the true & correct distances as ascertained by actual & careful measurement on the ground. and that the sketch accompanying these Notes is a true & correct representation as they actually are on the ground of all the aforementioned surveys and their surroundings - to wit, Maria Brennon Grant, J. Poterent survey N^o 312, J. H. Gibson survey N^o 310. John Ward survey N^o 333 and Bealy Seal & Fomrod survey N^o 209
