

Matagorda, Texas, Feb. 19, 1890

Field Notes of connecting lines run in
Matagorda County, February 1890.

Variation $9^{\circ}15' E$.

Beginning on the East bank of the
Colorado River "200 or more or less below a
small creek" at the West corner of the J. Betts
League No. 8.

Thence $N. 62^{\circ} E$. at 1543 vs Betts Creek, at 1580
vs across creek, at 1925 vs. Betts creek again,
at 1940 vs across same, at 2940 vs edge of prairie,
at 3596 vs. found an old stake marked
"O.B." for West corner of preëmption No. 7, in
name of A. W. Mangum; which preëmption was
formerly owned and occupied by Oscar Bailey;
the North corner post of this preëmption is gone,
Thence $S. 28^{\circ} E$. at 4602, vs. corner post, (a live
oak post in West corner of Nye's pasture bears
 $S. 69^{\circ} E$. 1323 vs. the course of fence from here
is $N. 45^{\circ} E$. and $S. 45^{\circ} E$.) at 5017 vs. intersects a
line, said line beginning at a post in an old
field fence on the dividing line between the
Bowman and Williams and Betts leagues, was
run $N. 62^{\circ} E$. passing about 10 vs N.W. of a
large live oak tree marked $\bar{\circ}$, said tree
stands at the N.W. point of a Mott of timber,
and continuing to intersection where a stake
was set for East corner of Betts league. Thence
 $N. 62^{\circ} E$. 90 vs. Thence (with Var. $8^{\circ} 30' E$), $S. 28^{\circ}$
 E . at 555 vs a post for corner on N.E. line of
Bowman and Williams league, at 795 vs another

corner, at 1519 vs. another corner post at 4173 vs. set a stake for East corner of Bowman and Williams league. Thence S. 62° W. Var. 9° 15' at 1805 vs. Cottonwood Creek; at 2586 vs found a post for the North corner of R. P. J. Stone as set by F. J. Hopp. Thence (Var. 9° 15' E).

Beginning at the stake set for East corner of Bowman and Williams league; the post at N.W. corner of M. O. Connell's pasture fence, which is the N.W. corner of D. & G. N. R. R. Survey No. 5 bears S. 77° 10' E. 920 vs. Thence N. 45° E. at 1833 vs. Nye's pasture fence; at 2430 vs. Buck Bayou at 3980 vs. pass about 14 vs. S.E. of a Wind mill, at 7692 vs to intersection with S.W. line of A. Rawls league.

Then beginning at the East corner of 200 acres to Phillip O'Connell, at 1007 vs S.E. of N.W. line of Amos Rawls league.

Thence S. 45° W. 2187^{vs} along O'Connell's S.E. line to south corner of ^{pasture fence} said 200 acres on the N.W. line of Amos Rawls league No. 2^{being} 1007 vs. S.E. of its W. corner. Thence N. 45° W. at 772 vs. to West corner of the small tract No. 2 being 235³/₈ vs. S.E. of W. corner of Amos Rawls league -

Then Beginning at South corner of 200 acres to O'Connell. Thence S. 45° E. at 960 vs. intersected line run N. 45° E. 7692 vs. from East corner of Bowman and Williams league at 2337 vs (or 2337 + 1007 = 3344 vs. from West corner of Amos Rawls league) set stake for S. corner of Amos Rawls league on N.W. line of Burnett and Sojourner league. Thence S. 45° W. 252 vs

to a large sawed live oak post for North corner of A. D. Rugeley's tract of 192 acres. Thence - Beginning at a post for S.E. corner of E. Hall league. Thence North at 1190 to Hubbers pasture fence. at 895 to S.E. corner of Hurst tract (at 1210 is the S.W. corner of Henry Gosling tract No. 1 bears East 1689 (as. $9^{\circ}30'$) at 1429 to corner at 2376 to Thompsons S.E. corner at 2763 to corner at 3515 to set stake. Thence West at 500 to Cottonwood Creek at 820 leaves the creek at 1779 to the stake found for North corner of Stone tract bears North 2494 to. a post said to have been set by Mr. Hoop can be reached by running N. 90 to and West 54 to at 6630 is Colorado River.
