Statement concerning the location of E L & R R R Co

75-76-73 Referred to Map

The work is based on the G M Williams
Base line and starts from his SW Cor H Brandes sur # 1596
The work by D H Clark on the E L & R R R Co has his
Bearings on the ground & easily identified and on
designated by X and show to be north and west of the
old line based on the Williams work

No 75 & 76 would conflict with 28 about 190 or so to
connect 76 which was state land it should be pulled
that much south to connect with north line 25 JH
which was based on the SW Cor 1602 JH Goellner
but only calls for course & distance so I conclude that
would be proper place to lay in 25

Now Clark called for his corner to begin on SW Cor of
7602 to be beginning Cor of his No 71 and made his
bearing line to corner 163 or N 79 or West of that point
and called it N 2 71. S 2 25 JH and then surveyed
to the West and made his line excessive East & West
and North & South until he reaches SW Cor 75 & 76
E L & R R Co

The distance from same Cor East to old line of Corners
at SW Cor Brandes sur 1596 & NW Cor 1601 JH Goellner
is 1065. or. The Fisher & Mills Colony surveys being
excessive would have an excess of land between 76
& No 26 which is based on the old Corners indicated
by O The difference between 79 & 115 comes by Clark
working to West & North, & making his survey excessive
I believe that No 26 is also excessive to extent of 53 x 1900
on the East. more than a 6 x 0.
