Now come KELLY STEPHENS, who resides in Johnson County, Texas, and MAGNOLIA PETROLEUM COMPANY, a private corporation duly incorporated under and by virtue of the laws of the State of Texas, with its principal office and place of business at Dallas, in Dallas County, Texas, plaintiffs, complaining of T. M. MARKHAM, who resides in Harris County, Texas; BASCOM GILLES, COMMISSIONER OF THE GENERAL LAND OFFICE OF THE STATE OF TEXAS, who resides in Travis County, Texas, and PRIOR DANIEL, ATTORNEY GENERAL OF THE STATE OF TEXAS, who resides in Travis County, Texas, defendants, and for cause of action plaintiffs will respectfully show the Court the following:

1.

On the 18th day of February, 1952, plaintiffs were and still are the owners in fee simple of the following described land situated in Midland County, Texas, to-wit:

If further pleading be necessary, plaintiffs allege and will show the Court that the Commissioner of the General Land Office of the State of Texas, purporting to act under the Act of June 19, 1939, being Chapter 3, Acts of the 46th Legislature of the State of Texas, Regular Session, made an award to T. M. Markham, assignee of James C. Wilson, Jr., of the area described in Tracts A, B, and C above, which attempted award to T. M. Markham is wholly void and without any force and effect because the land included in said award was not vacant and unsurveyed land and was not subject to disposition under the above Act, and had been theretofore duly and legally patented by the State of Texas and included in senior patents which are valid and subsisting, and said award constitutes a cloud on the title of plaintiffs herein.

WHEREFORE, plaintiffs pray that Bassom Giles, Commissioner of the General Land Office of the State of Texas, and Price Daniel, Attorney General of the State of Texas, each be served with a certified copy of this petition as provided by the above Act of June 19, 1939; that T. M. Markham be cited to appear and answer herein as required by law; that plaintiffs have title to and possession of the above-described tracts of land and that the above-mentioned

Come now Stanton Brunson, a resident of Lubbock County, Texas; Ohio Petroleum Company, a corporation organized under the laws of the State of Ohio, with a permit to do business in the State of Texas, and with an office at Houston, Harris County, Texas; and The Standard Oil Company (Ohio), a corporation organized under the laws of the State of Ohio, with a permit to do business in the State of Texas, and with an office at Houston, Harris County, Texas, hereinafter called Plaintiffs, each complaining of T. M. Markham, a resident of Harris County, Texas; Bascom Giles, Commissioner of the General Land Office of the State of Texas, a resident of Travis County, Texas; The Honorable Price Daniel, Attorney General of the State of Texas, a resident of Travis County, Texas; Magnolia Petroleum Company, a corporation organized under the laws of the State of Texas, with an office at Dallas, Texas; M. Now comes MAGNOLIA PETROLEUM COMPANY, a defendant in the above-entitled and -numbered cause, and for answer herein pleads as follows:

1.

As shown by plaintiffs' original petition, this defendant is made a party to this suit upon the allegations of Paragraph IV of plaintiffs' petition which alleges that this defendant claims an interest in lands adjoining the tract of land described in plaintiffs' petition by reason of which it is a proper and necessary party to an adjudication of this case. Defendants, for and in behalf of the State of Texas and the Permanent Free School Fund of the State of


Texas, by way of counterclaim and cross-action would show the Court the following:
