Dear Sir:-

Your letter of the 5th inst. in re, a vacancy of 306 acres lying northwest of the true northwestern line of the J. W. Asbury, to Mr. M. L. Womack, Jr., has been referred to me, with request that I make further explanation to you as to what I actually found upon the ground when I made a re-survey of that section of the country under my appointment from you as special state surveyor.

You state that I, in making a re-survey of Nos.5 and 6 H.T. & B. RR and other surveys to the northward, did not report a re-survey of the J. W. Asbury. He seems to have adopted a line for the northwestern line of the Asbury without having proved it by measuring on its western boundary a distance north 1640 varas from the San Jacinto river to a stake as called for in the original field notes of the Asbury, or making further investigation to determine whether or not the line he adopted was really the correct northwestern line of that survey.

I beg to call your attention to that part of my report which reads as follows:

"I then went back to the point of intersection of this line (mean ing the west line of the Short survey) with the west line of the McLean; thence S. 35 W. at 1927 varas to a sweet gum marked HBM, water oak bearing tree, p i n e witness tree gone, the S.W. corner of the Harrison McLean survey; thence S. 55 E. at 1089 varas cross line of Section No.5, as located from the N.E. corner of the Votaw survey, as fixed by Gillispie, in all 1314 varas intersect the west line of the J. W. Asbury League; thence S. 35 W 3874 varas a stake in the east line of the Votaw, one of the Asbury corners, from which a pine two feet in diameter marked A brs. N 7 W 11 feet and a

pine 18 in. diameter bears S. 7-1/2 W 40 feet: Thence S. 1640 varas to a stake on the bank of the West San Jacinto river, the S.E. corner of the Votaw and S.W. corner of the Asbury survey."

I took it for granted that as I had absolutely fixed the Votaw survey upon the ground from its connections with the Mary Owens league and the river, the proof was sufficient to identify the S.W. corner of the Asbury on the river, and 1640 waras north of said corner finding another corner in harmony with the Asbury field notes, although the witness trees just above described are not called for in the Asbury field notes. They seem to have been marked in the last fifteen or twenty years to perpetuate said corner. There are, however, old evidences of the original line of the Asbury running N 35 E. from this corner. I have a copy of Mr. Blackburn's field notes an.

and sketch of the survey made by him of 306 acres lying between the southeastern line of H. T. & B. Nos. 5 and 6 and the Harrison McLean and northwestern line of the J. W. Asbury, and he adopts the same corner as one of the corners of the Asbury. He then ties on to the line of No.6 as re-surveyed for Whitty & Langerman and upon which patents were issued, and then projects his sketch to show that No.5 connects at its northeast corner with the west line of the Short 66 varas north of its connection (No.5) with the west line of the McLean, when in fact, had he run out the connection he would have been forced to put the northeast corner of No.5 on the west line of the Short 418 varas north of the west line of the McLean.

If you will refer to the field notes of Section No.5 in patent to Mrs. Louise Virginia Wade, Assignee, dated May 10th, 1870, you will see that they call for a connection with the Asbury League. I have not a copy of the original field notes of Section No.6 as returned by Mr. Wade, the locating surveyor, but they must also call for the Asbury.

The whole trouble arose by the re-survey of the E. Votaw in 1878 by J. J. Gillispie, then County Surveyor of Harris county. The proof is positive that he took it for granted that the river in 1835 ran through an old channel 376 varas north of the present channel, and fixed the S. W. corner of the E. Votaw and S. E. corner of the Mary Owens League on north side of it, and ran out the Votaw from said point and established new points for its N.W. and N. E. corners. The original field notes for the Votaw call for two large pines as witness trees at its N.E. corner, while said corner, as re-established by Gillispie, is on the north bank of Benns Branch, where there never was any pine timber. When No.6 was re-surveyed into two parts, one for Langerman and the other for Whitty, the surveyor tied on to Gillispie's N.E. corner of the Votaw, with small hollys for witness trees, and committed a very great error. Gillispie's work also forces Section No.4 376 varas in conflict with the J. M. Everett survey to the northward. I found some of the original lines of the H. T. & B. Sections, and to follow them, they harmonize with the older survey for which they call.

Dear Sir:-

Acting under instructions contained in your letter directed to me, I made the following survey of the Elijah Votaw location and Sections Nos. 3, 4, 5 and 6 H. T. & B. R. R. Co.

I began at the North East corner of the Mary Owens League, which has been perpetuated, although the original witness trees are gone. Thence South at 4442 varas pass the N. W. cor. of the E. Votaw survey as established by Gillespie, County Surveyor of Harris Co., in 1878, in all 10291 varas to a stake on the North bank of old channel of river, claimed by Gillespie as the S. E. cor. of the Mary Owens and S. W. cor. of the Votaw, because the N. W. Cor. of the Votaw is exactly 5850 varas North of this point, the length called for in the Votaw field notes. I then went back to said NoW. cor. of the Votaw, as established by Gillespie; thence East at 1428 varas center of Benn's Branch at 1430 varas a stake on the North bank of said branch for North East corner of the Votaw as established by Gillespie, between two Hollys both marked X; this is also the N.W. cor. of Sec. 6, H. T. & B. R. R. Co.; thence East crossing Benns Branch several times at 482 varas a stake set for S.E. cor. Sec. 3, and an ell corner of No.6, from which a pin oak and pine are marked X; thence North at 144 varas, (Not 155-7/10) pass a stake the S.W. cor. of Section No.5 and N.W. cor of Sec. No.6, two pines and a black gum (Not an Elm but looks like one) all marked X for wit.trees, continuing North in all 1930 varas to a point for the N.E. corner of Sec. 5; thence East 1558 varas to a point for the N.E. corner of Sec.5; thence S. 66 varas to a point for cor. of No.5 on the N. W. line of the Harrison McLean Sur. and South corner of the M. H. Short Sur. I could not find anything here, so I was not satisfied with the position, and determined to locate the Short and McLean Surveys to see where this corner is really situated. I secured the Patent to the McLean Sur. issued in 1846, and signed by A.C.Horton, Governor and Thos. W. Ward, Com'r. of the Genl. Land Office, and the field

notes in it call to enter a prairie at 4400 varas S. 35 W. from its N.E. cor. I saw that said prairie was 400 or 500 varas a little S.E. from the point I arrived at for the West line of the McLean, following the field notes of Sect. 5 just mentioned. We finally found the McLean line down at the prairie and traced it out to the river or rather Caney Creek, its North or N.E. cor. The original witness trees are gone. From this point I ran S. 35 W. at 1320 varas cross White Oak Creek at 4500 varas pass intersection of an old line coming down from the North which is the West line of the Short Sur. on North edge of prairie. To verify this line, I ran North 4891 varas to a stake the N. W. cor. of the Short Sur., from which a White Oak 25 or 30 inches in dia. brs. North 2 varas, mkd. X, B.O. stump found, This old white oak fixes the N.W. cor. of the Short beyond a doubt, although there is an excess in the distance from it South to the McLean line of 491 varas. I then went back to the point of intersection of this line with the West line of the McLean: thence S. 35 W at 1927 varas to a Sweet gum marked HBM. water oak for bearing tree, pine witness tree gone, the S.W. corner of the Harrison McLean Sur: thence S. 55 E. at 1089 varas cross line of Sec. 5, as located from the N. E. cor. of the Votaw Sur. as fixed by Gillespie in all 1314 varas intersect the West line of the J. W. Asbury League. Thence S. 35 W. 3874 varas a stake in the East line of the Votaw, one of the Asbury corners, from which a pine 2 feet in dia. Mkd. X brs. N. 7 W. 11 feet and a pine 18 in dia. brs. S. 7-1/2 W. 40 feet. Thence South 1640 varas to a stake on the bank of the West San Jacinto River, the S. E. cor. of the Votaw and S. W. cor. of the Asbury Sur. I then decided to locate Sections 3, 4 & 5 from the S. W. cor. of the Everett Sur. and build them up South from said point according to Wades field notes. I began at the N. E. cor. of the Mary Owens Lea. Thence South 1210 varas to the S. W. cor. of the Everett: thence East at 2141-1/2 varas pass the N. E. cor. of Sec.4 at 3443-1/2 varas looked for N. E. cor. of R. Williams Sur. but could not find it, so continued East in all 3682-1/2 varas to the West line of the Short Sur. as the Williams calls for the Short; thence S. at 1190 varas established the S. E. cor. of the Williams Sur. and N. E. cor. of a vacant strip of land, at 1664 varas a point for N. E. cor. of No.5, 42 varas North of the West line of the McLean Sur, instead

of 66 varas as called for in the field notes. Thence West at 1.541. varas pass point for S. E. Cor. of Sec. 4, in all 1790 varas point in McAshans field for N. E. cor. Sec. No.5; thence South at 26 varas pass point for N.E. cor of Sec. 3, in all 1926 varas to point for S. E. corner of Sec. 3, as established possibly by Wade in 1861. Here I decided was the place to determine, if possible, where Wade found the North line of the Votaw Sur. in 1861, because in those days the Surveyors never created a shortage, but frequently put in excesses. We began to look for an old line, and 18 varas South of us we found evidences of an old one, by old decayed places on the ancient trees. We cut into these places on the trees and found the old hacks and blazes as plain as the day they were made, clear across West to the East line of the Mary Owens League. There are many rims of growth from said marks out to the present circumference line of the trees, which show that they were marked, no doubt, by the locator of the Votaw, and there is no doubt in my mind but what it is the line Wade recognized in 1861, when he was locating the H. T. & B. R. R. Co. Certificates. Gillespie located his N. W. corner of the Votaw from the old channel of the river to a vara, and the original locator must have unquestionably tied on to the present channel, which has always been the main channel. The dotted lines represent Sections 5 & 6, located from Gillespie's N.W. cor. in more recent years, but it is error to even suppose that said lines represent the foot steps of J. M. Wade in 1861, and furthermore, there are no old marks on the trees on Gillespie's North line of the Votaw, which ante-date 1878, the year he located it. With the facts as I found them upon the ground, I am convinced beyond a doubt that I found Wade's foot steps, and have resurveyed the Sections as he located them.
