I, James H. Parks, Surveyor of Donley County do hereby certify, that as Deputy Surveyor of the Jack Land District I made a connecting survey in block J, in Motley County, as given in the following field notes, July 28, 29, and 30, 1882.

Beginning at a stone mound on the south bank of South Pease rive identified as the N. E. cor, 235 at the mouth of Jacksons branch, now known as the fish holes.

Thence West 1900 varas to a pebble stone mound in sand draw, set by me for N. W. cor 235 and NE236, at 3800 varas set a peoble stone mound on top of a pidge in a sand hill between white flats and mouth of the Dutchman, for N. W. con 236 A. B. & M. cert 523.
