Before me, the Citizen and only Constitutional Judge, Jose Ignacio Ybarbo, and in the presence of my two assistant witness, with whom I act as provided by the law, personally appeared and in their proper persons, the citizens, Josefa Cordova and Rafael Bere, and the first stated: that she sold and sells in lawful sale unto Rafael Bere, one mile of land, from North to South on the Atascosa Creek on this side of said creek and on the place called "Patona"

BEGINNING the survey on the South side and thence in a Northern direction this survey is continued until complete one mile; Thence in a Western direction to the land of Pedro Elias Bean, and on the South side is bounded with the land of Melchora del Rio, deceased, and on the East it is bounded by land of the same vendor, and on the North side with land of the same vendor. And that said mile of land she gives in sale for the consideration of One Hundred Fifty Dollars, good money to her in hand paid, and to her entire satisfaction, and the receipt of which is hereby acknowledged by said Rafael Bére. Further stating that in case it is worth more or will be worth more he may be favored with the surplus, in a manner perfect and irrevocable, and that the right "LLAMA ENTRE VIVOS" for him his children, heirs and successors or whoever of him or them might acquire just title.

She renounces all the laws that may be in her favor, especially those that treat of things that are bought and sold for more or less than their just value, and that of the four years to retract errors, binding herself that if at any time a dispute should arise upon this sale to defend same until the said purchaser has acquired a quite and peaceful possession.
