I am herewith submitting a film of the survey on the South 1/2 of the A.B. Davis Survey 598, L.S. 197 on Mustang Island, Nueces County, Texas for G.L.O. approval of the Corpus Christi Bay Shoreline.

The stake which was too far out in the water on August 4th was incorrect. This angle point was eliminated and the shoreline was run between the preceding point and the following point. The two lines which were eliminated read North 21°07'39" East, 141.22 feet and North 61°52'38" East, 63.87 feet on the prints which were submitted on July 27, 1982. The line replacing these two call reads North 33°31'45" East, 194.13 feet on the film. The exhibits which were submitted on July 27, 1982 were drawn with the two lines as shown on the prints. The exhibits will also differ from the film in the location of the ruined pier on Corpus Christi Bay. At this location, a triangular piece of land which shows on the film does not show on the exhibits. The film correctly shows the 0.9 foot contour as it now exists.

The shore line shown on the survey is on the 0.9 contour whether natural or artificial except for one portion East of the Island.

The artificial shoreline mentioned in the last paragraph above refers to the shoreline along that portion of privately owned land which was washed out by Hurricane Celia and subsequently filled back in by Gulf Oil Co.. This fill was made on privately owned land and not on State owned submerged land.
