REPORT OF SURVEY 10, BLOCK D,

W. P. Wiser, Grantee.

At the N E corner of survey No. 1, Block 10, H T and B RR Co., being the S E corner of Block D, I found a stone set in the ground in a draw and from which an outcropping rock on the north side of draw is marked on its top surface H T C R R CO, bearing N 63 40' E, 60 vrs. (This bearing is compared to the old 100th meridian line)

I then ran North 586.44 vrs and found a rise in the ground, but no circular trench that would indicate it to be artificial. A field on the west of this rise would, in

years, naturally obliterate a trench. I set a rock here marked N E 1. At 1075.3 vrs is a large rock, 3¹/₂ feet high, by its descriptive marks being the old State Corner Monument.

Thence East 703.8 vrs from which the new 100th MeridianMon. bears North 12.2 vrs.

Having the report of J. D. Merrimanon the South line of Block D, made January 25th 1929, I checked his measurements on the eastern portion of block D and found them to correspond truly with mine; I therefore transfered my work to the western portion of the Block and at a Zinc cone in the U S Gov. survey, called for in the W D Twichell'as "28 miles plus 1304(1304) vrs bearing N. 82 vrs."

Thence South 82 vrs for his North line of Texas; South 955 vrs to a fence that apparently is on a section line;

Thence West 909.2 vrs to center of Highway bearing N and S. (I could not find a rock here but the road was graded after the Merriman survey and the rock would be displaced) 945.2 vrs to a point from which a stake set at a post south of a graded road road beras South 8 vrs. This was Merriman's check for the S W corner of survey 9 and S E corner of survey 10, being 55485 vrs West from the S E corner of Block D.

Thence West 290 vrs to turn of road north, 300.6 vrs a fence bearing north, 1510 vrs a point for the S W corner of the Evan Anderson tract, 127972xmrs1550.2 vrs the N E corner of Ochiltree and the N W corner of Lipscomb Counties bears North 952.5 vrs 1879.2 vrs the N W corner of survey 30 in center of N - S Highway, 2854.2 vrs a U Cov. Zinc cone bears North 1033.5 vrs, 3794.4 vrs a stone and pipe set for the NW corner of survey 31at intersection of an E -W- S road, 5709.4 vrs the N W corner survey 32 at turn of road south. (No corner was found but Mr. Doerrie, on survey 10, says a 4 pit corner was here before the road was graded) 6165 vrs the S W corner of survey 10, Block D, from which a fence bearing south is west 23 vrs; A fence bearing north is west 30.6 vrs.

Having found all these measurements to correspond to those of J. D. Merriman's and closely corresponding to those of W. D. Twichell, in his State line work I accepted the Stake in road 36 vrs west of the N E corner of arvey 30, Block 10, as the S E corner of survey 10, Block D, and at said point I set a 1 " pipe, marked S E 10 and completed the survey of 10 as found in the accompanying Field Notes.
