Bear Sir:

In accordance with instructions in your letter addressed to Mr. T.H. Rawls under date of Oct. 27, 1933. I proceeded to tie the corners in Block 14 G.H & S. A. Ry Co., to some established corner in Block 204 T & St L. Ry Co., in order to determine the extent of the conflict between these block and prepare field notes of survey 22, Blk 204. Following are connections made:

Beginning at The S. E. Corner 47 Blk. 14 we ran North and at 1900 varas found the N. W. 47 as placed by Reavis in running this line checks were made on canyons as called for in the Reavis Field notes. We then ran west 2 miles and established the N.W. 33 Block 14. Returning to N. E. 33 we ran north 950 varas and West 1900 varas and established a Rock mound.

Checking the field notes of the T. & St. L. Blocks, I found that the N. W. 6 Blk 204 called for S. W. 31 Blk 203, and as the N. W. 6 Blk 203 has an established original corner with a bearing on San Jacinto Peak, we rea South from N. W. 6, Block 203, 11400 varas and placed the N. W. 6 Blk 204 and S. W. 31, Block 203.

We then ran south 3800 yaras and East 7600 varas and established a point at N. E. 11 Block 203.

From this N. E. 11 we ran South 513 varas and East 460 varas and connected with our N.W. 33.

This gave us the tie between the two blocks upon which the enclosed field notes are based.
