REPORT OF A SURVEY

M ade to determine the true position of Surveys 1,918,7,6,5 & 4 in John J. Terrell, Thos. C. Crosson and J.H. Jaff, S.F. and adjacent lands in the Southeastern part of Presidio County, Texas, August and September 1941.

I was furnished a working sketch from the General Land Office at Austin, Texas, based on various ties to old established corners by a survey and report made by R.S.Dod, dated in 1915-16&17, which I used for a basis for my survey.

Beginning at a rk. md. mkd "NW24" in Block 14, G.H.&S.A.Ry. Co.

THENCE South 1895 vrs. to a point 19 vrs. North of an "X" cut on a large rock, being the bearing called for in the original Field Notes. The "X" called for in the original Field Notes as being 4 vrs. East was not found, but a large boulder answers the description and distance which is under high water and has likely been obliterated by sand and rocks washing over it. This would be the S.E. corner of Survey No.13 in said Block 14.

THENCE I went on South at 1916 vrs. I found a rk.md. mkd. "S.W.25" for the S.W. corner of Survey No.25 said Block 14.

THENCE South at 950 vrs. I found a small rk.md.mkd "N.E.11" brs. West 502 vrs. which checks very closely with R.S.Dod's report. I continued my line South 4055 vrs. to a point

THENCE West 500 vrs. found a rk.md. mkd. "S.E. 11". From this md. I ran ran N.13deg.36'E. 63.8 vrs. and made a rk.md., mkd. the cap rk. "T" for the N.E. corner of Survey No. 513 and N.W. corner of Survey No. 514

I then ran S.80deg.W. 1882.6 vrs. and made a rk.md., mkd. the cap rk. "X" for the S.W.corner of Survey No.1, Terrell, Crosson & Taff. This being 17.4 vrs. N. 80deg. E. from the N. W. corner of Burvey No. 513.

I then constructed the surveys as shown on plat in Field Notes submitted. My corners and distances conformed so close to R.S. Dod's work that I took his work as being correct instead of making the few minor changes.
