REFERRED TO MAP

Herewith please find traverse line, notes and ties on Blocks 203-209-204 T. & St.L.Ry.Co., Block 14, G.H.&S.A. Ry.Co., Presidio County, Texas in re T.H.Rawls ranch, as surveyed by me on the ground in Oct. & Nov. 1941 and Feb. 1943.

These surveys were made by me for corrected Field notes to patent, which were mailed with tracing sketch of same to your office last Saturday, March 6th.

The traverse line begins at the NW corner of Block 203, T & St.L.Ry.Co. at a rock mound marked "AXVIII" and from whence San Jacinto Peak bears N. 26 deg. 30'E, and Bench Mark 4125 bears N. 15 deg. 30'W. 416 vrs. THENCE following the Rim Rock as shown in the Corrected Field Notes to a point in the East line of Section 12, Block 203 and West line of Section 7 ,Block 209.

THENCE along said Rim Rock N. 73 deg. 36'E 368 vs.; N. 68 deg. 30'E. 474 vs.; S. 65 deg. 31'E. 156 vs.; S. 72 deg. 19'E. 168 vs. to point on Rim Rock

THENCE down off of Rim Rock N. 67 deg. 19'E. 1524.1 vs to X cut on rock on East side of road.

THENCE N. 17 deg. 44'W. 666 vs.; N. 30 deg. 59'W. 324 vs.; N. 13 deg. 23'W 332 vs.; N. 8 deg. 34'W. 475 vs.; N. 0 deg. 07' W. 317 vs.; N. 79 deg. 42'E. 138 vs. to the NE corner of Section 6, Block 209, T & St.L.Ry.Co.

THENCE back to the X cut on the rock on the East side of the road and ran as follows:

THENCE S. 89 deg. 41'W. 5678.1 vs.; N. 0 deg. 19'W. 2681.3 vs. ;S. 89 deg. 41'W. 1640 vs.; S. 56 deg. 57'W. 834 vs. to the SE corner of Section 2, Block 204, T & St.L.Ry.Co.

This work was done in October & November 1941. These notes have been corrected to 12 deg. 12'E. variation instead of 12 deg. 05'E.

In February this year I began at a rock mound marked "AXVIII" the NW corner of Section 6, Block 203, T & St.L.Ry.Co. f from whence San Jacinto Peak bears N. 26 deg. 30'E. and then ran S. 45 deg. 13'E. 11087 vs. to Bench Mark 4845 and on same course S. 45 deg. 13'E. 16128 vs. in all to a point. I looked high and low for a rock mound but could not find any. I then ran S. 45 deg.


