Enclosed herewith you will find map and fieldnotes of two surveys in Reagan County.

A glance at the map will show that the South line of Survey No. 1, Certificate No. 118, C. & M. RR Co., is built at right angles to the West line of Block 49, University Land, as resurveyed by Frenk F. Friend, and conforms in course and distance with his map dated December 6, 1935 and filled in the Land Office December 17, 1935; while its West line follows the East line of Survey No. 30, Block 11, University Land, as resurveyed by Frank F. Friend, fieldnote distance, to establish the SW corner of Survey No. 2, Certificate No. 5036, G. C. & S. F. RR. Co. From here, the South lines of Surveys Nos. 1 and 2, same Certificate, were put in parallel to the South line of Survey No. 1, Certificate No. 118, and are given their fieldnote distance. Thence, a line was run at right angles northerly to strike the South line of Survey No. 228, T. & P. RR Co., as resurveyed by H. M. Garden. The three resurvey corners shown on the map along the South line of the T. & F. RR Co. Block 1 are proved by their bearings fitting the fieldnote calls, and as the corner called for at the SE corner of Survey No. 229, said Block, falls in the old and now abandoned Big Lake-Barnhart Highway, and the rock is probably destroyed, the South lines of Surveys Nos. 229 and 230 are formed by the rocks found at the SW corner of Survey No. 229 and the SE corner of Survey No. 230. The distance between these rocks was equally divided between these two Surveys, and the NW corner of Survey No. 3, Certificate No. 970, H. E. and W. T. RR Co., was put in 637 varas West of the thus formed SW corner of Survey No. 229.

A perpendicular dropped from this corner to strike the North line of Block 49, University Land, forms the West line of said Survey No. 3. The East line of Survey No. 1, Certificate No. 418, C. & M. RR Co., is made to parallel its West line as established by Block 11, University Land, and its SE corner, as formed by alloting the fieldnote distance from its said West line, forms the SW corner of Survey No. 2, same Certificate. This construction will give said Survey No. 1 its patented acreage and the space between it and Survey No. 3, Certificate No. 970, H. E. and W. T. RR Co., becomes Survey No. 2, Certificate No. 418.

The construction of Survey No. 2, Certificate No. 2289, G. C. & S. F. RR Co., is not as difficult inasmuch as it is put in at right angles and parallel to the West line of Block 49, University Land, as resurveyed by Frank F. Friend, receiving its North-South excess from this resurvey.

These two fieldnotes are being filed at the request of Mrs. Lulu Wilson Young, owner, who intends, I believe, to patent them.
