## REPORT ON SURVEY MADE IN THE AREA ADJACENT TO STILES, REAGAN COUNTY, TEXAS.

In October 1927 I did my first surveying in this area.

I began at the S.E. corner of survey No. 1210 D. & S.E.R.R.Co., an Iron Pipe in the center of the Big Lake & Stiles Road, from which a Mesq. brs. N. 61° W. 50 vrs. and Mesq. stump brs. S. 84° 45' E. 84 vrs. and a Set Rock marked N.L. 1209 brs. West 11.3 vrs.

Thence West 1900 vrs. and looked for Mesq. bearing tree called for in field notes (tree was gone).

Thence North and found the stone md. called for in field notes, making the N. & S. lines of survey 1210 a distance of 1906 vrs. and the E. & W. lines a distance of 1928.3 vrs.

Thence S. 89° 58' W. 2135.3 vrs. to an old stone md. the N.W. corner of survey 1213 D. & S.E.R.R.Co.

Thence S. 0° 21' E. 1905 vrs. to an old stone md. marked N.W. 1214 from which a 6" Mesq. marked K brs. N. 42° 45' E. 17.8 vrs., the S.W. corner of survey 1213.

Thence West 5705.1 vrs. to an old stone md., the S.W. corner of survey 1222 (now a 14" x 16" mudsill in this corner)

Thence N. 0° 18' E. 3828 vrs. to an old Rk. md. the N.E. corner of survey 1224 E.L. & R.R.R.R.Co.

### February 1928

I began at the N.E. corner of above survey 1224 E.L. & R.R. R.R.Co.

Thence East at 4491.5 vrs. pass a stake and stone md., the S.W. corner of Theo Carter survey, in all 4715.5 vrs. to an old sto. md. the S.W. corner of survey 12 G.C. & S.F.R.R.Co., from which an Iron stake in a stone md. brs. East 50 vrs.

Thence North at 442 vrs. pass 54.6 vrs. to the West of old stone md., the S.E. corner of survey 13 D. & S.E.R.R.Co., at 2332.5 vrs. pass 59.5 vrs. to the West of old stone md. the N.E. corner of survey 13, in all 2511 vrs. to an old stone md., the N.W. corner of survey 12.

Beginning at old stone md., the N.E. corner of survey 13 D. & S.E.R.R.Co.

Thence N. 89° 30' W. 1909 vrs. to old stone md., the N.W. corner of survey 13 and the N.E. corner of survey 14.

Thence N. 89° 30' W. 1925 vrs. to old stone md., the N.W. corner of survey 14 and the N.E. corner of survey 7 E. L. & R.R.R.R.Co.

Thence N. 89° 30' W. 1900 vrs. to old stone md. the N.W. corner of survey 7 and the N.E. corner of survey 8.

### December 1930

I began at old stone md. the N.W. corner of survey 1223 E.L.

Thence West 1915 varas to an old Rock md., marked one Rock N.E. 1229-s, from which 8" Mesq. marked  $\bar{X}$  brs. S.  $3^{\circ} 30' W.$  5.9 varas and a fixed Rock marked  $\bar{X}$  brs. S.  $62^{\circ} 45' E.$  8.3 varas., the N.W. corner of survey 1224 and the N.E. corner of survey 1229 G.C. & S.F.R.R.Co.

Thence West 1915 varas to a Set Rock marked N.E. 1230-s, from which a stone md. marked "Lea" brs. S.  $76^{\circ} 25' E.$  48.5 vrs. and a stone md. brs. N.  $76^{\circ} 15' E.$  13 vrs., the N.W. corner of survey 1229 and N.E. corner of survey 1230 G.C. & S.F.R.R.Co.

Thence West 1915 vrs. to a Set Rock marked N.W. 1230-s, the N.W. corner of survey 1230 and the N.E. corner of survey 1204 G. C. & S.F.R.R.Co.

Thence West 3830 vrs. to 2" Iron Pipe recently placed in old stone md., the N.W. corner of survey 1203 G.C. & S.F.R.R.Co.

I also made a tie from the S.E. corner of S. A. & M.G.Ry.Co. survey 1947 to the old stone md. at the N.W. corner of survey 1203 which checked very closely to the call.

I also began at the S.W. corner of survey 6 Blk. L and the S.E. corner of survey 22 Blk. K made by me for R.E.Ringo, an Iron Pipe in a md. of stone.

Thence S.  $13^{\circ} E.$  at 21 vrs. East and West fence, at 1807.6 vrs. East and West fence, in all 2100 vrs. to a Set Rock marked S.W. 18 and N.W. 2-s, and being 10 vrs. South of the center of the old Centralia Road, from which a Bunch of Chapparal brs. N.  $82^{\circ} W.$ , for the S.E. corner of survey 21 Blk. K, D. & S.E. R.R.Co. and the S.W. corner of survey 18 Blk. L, D. & P. Ry.Co.

I then went to the N.E. corner of survey 16 Blk. L, D. & P. Ry.Co., which I identified from its two cedar bearings which are still standing, at which corner I set a Rock marked N.E. 16-s.

I then ran S.  $13^{\circ} E.$  2033 vrs. to a Set Rock marked S.E. 16-s. This corner being place in the S.W. corner of survey 18, the S.W. corner of survey 17, and the S.E. corner of survey 17, the latter corner being placed 25 vrs. South of the Old Centralia Road to respect its call, bearing trees gone.

I prorated the excess in this three miæs giving each survey 1927 vrs. At the S.E. corner of survey 18 and the S.W. corner of survey 17, the Bunch of Brush on Hill fit the course called for but the Mesq. bearing tree was gone.

The above will give you the corners which I took to be original corners and the method used in identifying them.
