I desire to make a statement
in connection with my resurvey of
Block F. - S. H. v S. A. R. R. Co. Edwards
I went to S. E. corner of Section 20,
Block 12. T. W. N. G. R. R. Co. established
by Hodges & M. C. Crickett, April 1893
and established by decree of Court
in Cause No 126 District Court of
Edwards County, Kate G. Gilbert
vs J. J. Godbolt & W. A. Buchanan
Decree recorded in Book 4 Pages 495
From said corner a line Oak stump 12" br.
S 55 1/2° E 53.6 ch. - a line Oak 12" mkd x br.
S 89 1/2° E 76.9 ch. (The last bearing tree was marked
by me. I ran a traverse line along
the old Leakey and Barksdale road
to Station A. made by me in spring
of 1890, on a slope near said road
in dry creek Cañon said station A. is
a steel wd. mkd. A. and the field notes
of my connecting line, run in 1890
shows connection between original
S. W. corner of Sec. 71 S. P. R. R. Co. on
E. bank of Mees River and station A.
My connecting line with sta A. showed
that - Hodges & M. C. Crickett put S. E.
corner of sec. 20 in a correct position
I established - S. W. cor. of sec. 2 Block 12.

Also S, E. ~~Cor.~~ & S.W. Corners of Sec. 71
Block 3 T. N. N. G. R. R. Co. and in making
Traverse from S.W. Cor. of 71. - I made
a monument on side of the road
for every mile or 1900 \pm of Westing's
These Monuments I witnessed
and their position is shown on the
certified sketch which I turn in
with this statement and the field notes.
At monument on W. line of sec. 73 I ran South
and connected with the N.E. Cor. of Sec 4
Block F. G. H. & S. A. R. R. Co. as made by
me in Spring of 1890. I also made a
connection on ground. from the new
S.W. corner of Sec. 8 Block F. to the corner
made by me in 1890. which old corner
is N 211 \pm & West 85 \pm . The last monument
made by me is on W. line of Sec. 62
Block 3 T. N. G. Ry Co. on south side of
road in Dry Creek Canon. This monument
is according to a most careful traverse
471 \pm S. of N.W. corner of Sec. 62
From this monument, the old stone
md. mark A. at station A. made by me
March 1890 has West 870.4 \pm & North 86.5 \pm
The work done by me in 1890 was at a
variation of $9^{\circ}45'$ E The M^r. Crickett work
was at $9^{\circ}15'$ E, - In my ^{last} correction I used
same variation as M^r. Crickett used
The work done by me in 1890 also falls
short in distance as a drag chain was.

used, over a mountainous country exceedingly rough. - My check, along a smooth route shows the mountain work to be short from 25 to 30 1/2 to the mile

I have corrected Block F. from the ground connections made at S.E. corner sec. 7, the N.E. corner of sec. 4, using the old corners as bearings

Statement concerning Block O.

J & N.O. R.R. Co. Edwards Co.

I carried a traverse from S.E. corner of sec. 20 as made by Hodges & Mc. Crickett to Leakey and along road up Fris Canyon to sec. 16 Columbus Tap R.R. Co. I made several monuments on side of the road and witnessed them. These monuments are all shown on sketch. Connection is shown with line drawn due North from S.E. cor. of sec. 20 Block 12 J. W. N. G. R.R. Co.

on which squares are drawn each 1900 1/2 square. - Sta A. for instance is 3 miles N & 674.6 1/2 E. of said S.E. cor. 20 and Sta E is 8 miles North & 421.8 1/2 West of said corner.

From S.W. corner section 16 Columbus Tap R.R. Co. I carried a traverse line to N.W. corner of sec. 17 Block O, J & N.O. R.R. Co. Keeping up the connection from S.E. cor. sec. 20. Bl. 12. I then went to witness corner on S. line of sec. 71 S.P. R.R. Co. - on the

The road on Fris Cañon and
Brushy Creek Cañon, well all
carefully established and can be
used ^{safely} as working points from
which to establish corners of near
by surveys.
