

Kerrville, Texas, December 29th, 1933.

Statement of A. L. Stakkey, a State Licensed Land Surveyor of Texas, as to the position of a number of Surveys in the Northeastern part of Real County, reference is made to accompanying plat, which is the correct position of those several Surveys thereon mapped, and those corners and lines found and ran by me on the ground.

Reference is also made to a map filed by me in the General Land Office some years prior this time, which will explain my reasons for making this Survey and submitting this plat and statement. In otherwords, the work represented and shown by this sketch and statement is based upon what was done formerly by me on the ground.

I call your especial attention to a corrected line shown on the former sketch as well as this sketch, replacing all other lines, beginning at the N. W. cor. of Sur. No. 21, T. C. Ry. Co., and runs S. $0^{\circ} 46'$ W. to the S. E. cor. of Sur. 29. This line affects the W. lines of Surs. Nos. 42 and 28, and the E. line of Sur. No. 24, T. & N. O., the only slightly. It clears up a confusion as to the position of a number of Surveys along its course on either side.

Survey No. 24, T. & N. O. Ry. Co.,

Shown in former sketch, I located S. W. cor. of Sur. No. 24, Ran East 1220 to corrected line. Ran N. $0^{\circ} 46'$ E. 1900 vs. with corrected line for N. E. cor. of No. 24. Thence ran West 1245 vrs. to its N. W. cor. Thus it embraces 411 acres of land.

Survey No. 42, G. C. & S. F. Ry. Co.,

Ran from N. E. cor. of Sur. No. 24, as corrected, East 1866.5 vs. for its N. E. cor. From same beginning ran S. $0^{\circ} 46'$ W. 1900 vs. to the S. E. cor. of Sur. No. 24, as corrected. Ran East 1891.5 vs. to rock md. by me, with bearings shown on sketch, for its S. E. cor. Thus it contains 632 acres.

Survey No. 28, G. C. & S. F. Ry. Co.,

From the S. E. cor. of Sur. No. 24, as corrected, ran East 2048.5 vs. to the N. W. cor. of Sur. No. 31, as corrected on former sketch, for N. E. corner. From S. E. cor. of No. 24, as corrected ran S. $0^{\circ} 46'$ W. 1295 vs. to the S. E. cor. of 29, as shown on former sketch. Ran E. 115 vs. rk. md. for made, for N. E. cor. No. 35, at 2064.5 vs. for S. E. cor. of 28,

rk. md. with bearings shown on sketch. Contains 471 acres.

Sur. No. 32, G. C. & S. F. Ry. Co.,

This Survey as shown on sketch, begins at S. W. cor. of Sur. No. 31, as shown on sketch, runs out a full 640 acres.

Survey No. 36, G. C. & S. F. Ry. Co.,

Beginning at the N. E. corner of Sur. No. 35, as located by me. Ran South 1793 vs. (full distance) to S. E. cor. of No. 35, and in the N. line of Sur. No. 1544, ran and established by Walton and Arneson, Engineers of San Antonio, Texas. Ran N. $88^{\circ} 51'$ E. 1751.5 vs. with Walton & Arneson line to old rock md. for N. E. cor. of No. 1544, and N. W. cor. of 1543. Thence S. $89^{\circ} 11'$ E. 732 vs. with W. & A. line to rock md. set 767 vs. S. of S. E. cor. of Sur. No. 32. Embracing 441 acres.

Survey No. 34, G. C. & S. F. Ry. Co.,

The South line of this survey and S. line of Sur. No. 26, C. C. S. D. & R. G. N. G. Ry. Co., was located by Walton and Arneson and checked by me, by identifying on the ground the original S. E. cor. of No. 26, and N. E. cor. of No. 1545, (a rk. md. a ced. 14" bears N. $57\frac{1}{2}^{\circ}$ E. 14 vs.) Thence running N. $89^{\circ} 11'$ W. 2741 vs. for the S. E. cor. of Sur. No. 26, and on in same course to the old rock mound for N. W. cor. of No. 1543. The N. line of Sur. 34, was located by identifying the N. W. and N. E. cor. of Sur. No. 23, C. C. S. D. & R. G. N. G. Ry. Co., From these corners I ran South on E. & W. lines of 23 and 24, as corrected by W. R. Fletcher in 1904 and the E. & W. lines of 33, as shown on this and former sketches.

From the S. E. cor. of Sur. No. 33, I ran South 800 vs. intersecting the N. line of Sur. No. 26, 525 vrs. E. of its N. W. corner. From the S. W. cor. of No. 33, I ran South 1329 vrs. to the S. E. corner of No. 32, at 2096 vs. to the N. line of Sur. No. 1543, as ran by Walton & Arneson. Thence S. $89^{\circ} 11'$ E. 1646 vs. to the S. W. cor. of Sur. No. 26. It encloses 688 acres of land.

As to Walton & Arneson they seem to have taken a great deal of time and pains with their work. The Messrs. A. D. and Archie Auld who own the land surveyed by me are entirely willing to accept the line ran by them. Also the people owning Surs. Nos. 1543, 1544 and 1545, are entirely satisfied with their lines. While it increases the area somewhat I am willing to accept also. Taking into consideration the fact that the

ground is very rough and broken, and that many files have swept over that region, destroying timber and land marks, I think the construction I have placed on the several surveys involved is entirely correct.
