00. N 78° E. 360.00. S 74° E. 210.00. N 53° E. 180.00. S.
61° E. 100.00. S 67° E. 100.00. to the N.W. Corner of
a survey in the name of C. J. Vernon, a Mulberry 6 In. diam. for the N.E. Corner, from which an
Elm, 10 In. diam. br. N 86° W. 1 1/10.00. also a Hack
berry 4 In. diam. br. S 49° W. 5.00.

Thence S. 14° W. with the N.W. bound-
ary of said survey, at 900.00 leave timber, at
15.069.00. Set post in mound for the S.E. corner,
from which a Musquit 4 In. diam. br. N. 4° E.
150.00. also a Live Oak 4 In. diam. br. N 21°
E. 120.00.

Thence N. 76° W. at 1667.00. inter-
sected the S.W. boundary of a survey in the
