Dear Sir:

During recent surveying southwest of San Augustine, the county seat of San Augustine County, I found considerable excess acreage in two surveys, namely Abst. 567, S.P. RR Section # 2 and Abst. 564, S.P. RR Section # 8. Both of these surveys are owned by the Southwestern Settlement & Development Corporation, and I advised said corporation to file applications to purchase such excess acreage.

Accompanying this report is a map, scale one inch: 400 varas, showing the two surveys and their neighboring surveys, as found on the ground. All field note distances are shown in parenthesis and the actual course and distances given on the map are the result of transit field work. A photostatic copy of the calculation sheet is attached to the respective survey file. Dashed lines on the map indicate those lines not actually or completely run in the field.

In the entire area under discussion, I was able to identify only the northeast corner of the J.L. Norwood Survey and the southwest corner of the Wm. Clark Survey. All other corners are either well recognized and established or accepted by the United States Forest Service, who own S.P. RR Sections # 1,3,5 and 7. The Southwestern Settlement & Development Corporation owns S.P. RR Section # 2, 4,6,8,10 and part of # 9. Please note from the map, that some of the distances measured on the ground are considerably different from the calls given in the original field notes. Two extreme cases are discussed as follows:

Abst. 567, S.P. RR Co. Section # 2: The west line of this section is 223 vrs. longer than it calls for in the original field notes. The southerly east line is also longer by practically the same distance. Discovering these excess distances, I took this matter up with the Southwestern Settlement & Development Corporation. The present owner of S.P. Section # 1 is the United States Government of America, and the land is under the supervision of the Forest Service, Department of Agriculture. The officials of the United States Forest Service contend that they acquired S.P. RR Co. Section # 1 on December 21, 1935 from the Long-Bell Lumber Co. Sales Corporation and accepted the lines and corners, after " a careful consideration of all original patented survey descriptions and maps available after due and diligent search." And since the field notes to S.P. Section # 1 do not call for S.P. Section # 2, but vice versa, it is my opinion that S.P. Section # 2 will have to go to the marked north line of S.P. Section # 1 where it is accepted by the Federal Government, based on old findings by its predecessor in title. The Southwestern Settlement & Development Corporation has letters on file from the United States

Forest Service to the effect that they will, under no circumstances, change the present location as set forth by corner descriptions in the deed from Long-Bell Lumber Company to the United States of America. Said corner descriptions, although they are not the original bearings, were found on the ground. From the map and the corrected field notes for S.P. RR Section # 2, you will note that I found the most northerly northeast corner fo S.P. RR Section # 1, 16.14 varas East of the accepted west line of the S. Pearse Survey. Since this Pearse Survey is senior to the Sections, I placed the southerly southeast corner of Section # 2 in a straight line between the two most northerly north corners of Section # 1, as accepted by the United States Forest Service and the intersection with the west line of the S. Pearse Survey.

Abst. 564, S.P. RR Co. Section # 8: All lines and corners of this Section as described in the corrected field notes are old and well recognized. The only exception is the northerly west line of S.P. RR Section # 8. From the map you will note that the most northerly north line and the northerly south line of this Section is 209.29 vrs. and 173.14 vrs. respectively, in excess over the field note calls. This matter also was taken up with the United States Forest Service, since S.P. RR Section # 7 belongs to the United States Government. Again, said United States Forest Service maintains that the location of their lines are based on old work by the Long-Bell Lumber Company, the predecessor in title of this survey and that they refuse to change the location of the easterly east line of their S.P. RR Section # 7 for this reason. Although Sections # 7 and # 8 were both surveyed on April 20, 1880, it is presumed that Section # 8 will follow the location of Section # 7, therefore, the corrected field notes to S.P. RR Section # 8 will go to the corners identified as to the United States Forest Service field notes.


Any further information desired on the location of the above discussed lines could be furnished by the Southwestern Settlement & Development Corporation or the United States Forest Service, Department of Agriculture.

Survey N No. 2, a stake witnessed by old marked bearing trees: a 9" hickory bears S. 280 E., .13 chain distant and a 14" hickory bears N. 73030' E., .20 chain distant.

Thence S. 0°50' E., with the lands of Southwestern Settlement and Development Company, common to the Charity Sanders Survey and the John H. Kirby Survey No. 2, 22.90 chains to corner 15, the tenth corner of S. P. R. R. Co. Survey No. 1 and the beginning corner of the John H. Kirby Survey No. 2, a F. 
