Beginning at the S.W. corner of  
a survey in the name of John Poland, in the  
Centre of the Laguna De La Cruz (for the N.E.  
corner of this survey)

Thence West. at 5000. v<sup>s</sup>. set post for  
the N.W. corner, from which a Musquit marked  
C. br. N 69° W. 25. v<sup>s</sup>. also a Musquit. marked  
F. br N 70° W. 36. v<sup>s</sup>.

Thence South at 440. v<sup>s</sup> a Water hole,  
40. v<sup>s</sup> wide, at 2030. v<sup>s</sup>. crossed John Nails Northern  
boundary 160. v<sup>s</sup> N. 81° W. from his N.E. corner, at 2980.  
v<sup>s</sup>. crossed John Nails East boundary 800. v<sup>s</sup> S. 9° W.  
from his N.E. corner, at 5000 v<sup>s</sup>, set post in mound  
for the S.W. corner (in a chiparel)

Thence East, at 5000. v<sup>s</sup>. set a post, for  
the S.E. corner, from which a Graneal 4 In. diam.  
br. S 82° W. 16. v<sup>s</sup>. also a Graneal 2 In. diam. br. S 60°  
E. 33. v<sup>s</sup>.

Thence North. at 4920. v<sup>s</sup>. the Laguna De  
La Cruz, 5000. v<sup>s</sup>. to the beginning corner.

Timber Live Oak, and Musquit.

This survey contains to the best of my belief  
five labas arable land, the balance pasture land.
