The State of Texas, which intervened herein as a plaintiff; Mrs. Elme Ramsey, a widow, Mrs. Josephine Ramsey, a widow, A. D. Aiken, A. E. Ramsey, Mrs. Winifred Fox and her husband, E. J. Fox, T. A. McKamey, Mrs. Fanny D. Wilson, a widow, T. A. Fisher, Mrs. Nina Wells, a widow, Inez B. Willis and her husband, L. R. Willis, May Miller and her husband, Rhea Miller, Ivy McAnelly Brown, a widow, J. W. McKamey and his wife, Maude E. McKamey, and R. H. Hamilton, J. F. Odem, Eda B. Odem, W. S. Everhardt, Mrs. C. O. Fritter and her husband, S. J. Fritter, Mrs. M. O. McGloin and her husband, R. B. McGloin, Florence E. Hunter, a feme sole, Annie McGloin, a feme sole, Jas. H. Ewing, Eliza H. Welder, a feme sole, Christina Beggs Arnold, sued herein individually and as independent executrix of the last will of Claude G. Arnold, deceased, Anne Lee Drummond and the San Jacinto Trust Company, a corporation, trustees under the will of Joseph Hudson Drummond, deceased, and Anne Lee Drummond in her individual capacity; and a jury having been waived all matters of law and of fact were submitted to and considered by the Court, and the Court having heard the pleadings of the parties, the evidence introduced, including the report of the surveyor heretofore appointed by the Court in this cause, and the argument of counsel and certain stipulations filed herein by the parties to this cause, is of the opinion and now finds that the land involved in this suit

has been formed by natural, gradual accretion to the riparian land which it adjoins, and that said land so formed by accretion is owned by the various parties hereto as hereinafter set out, and the Court further finds that absolute fee simple title to the land set aside hereby to each of the respective parties is vested in each of said parties respectively;

It is therefore ORDERED, ADJUDGED AND DECREED by the Court that title to said respective tracts of land be and they are hereby vested in the parties to this suit as follows, to-wit;
