I herewith inclose a sketch and field notes of two lines recently run by me to locate the SE Corner of Survey No. 1 G & S F R R Co. Blk EEE and the SW Corner Survey No. 7 T W N & R R Co. Blk 9. I find an excess of 118' or between the SW Cor of Survey No. 49 G & H and S A R R Co. Blk L as established by State Surveyor G M Williams and NE Corner Survey No. 16 H E and W T R R Co. Block A as established by W B Silliman and approved by D W Maddox, County Surveyor of Woodward Co. Please examine the accompanying sketch and see if I made the survey in a way that would be approved by that department or should the north line of Survey No. 16 only take course and distance of original call. East, <sup>(960' or)</sup> which would leave a small strip of State School land between Survey 16 Blk A and Survey one Blk 9. Again: Should the NE Corner of said Survey 16 and the SE Corner of Survey one Blk 9. be one and the same corner regardless of the variation of the two blocks? Are there

Dear Sir:-

This office is in receipt of your letter of 10th. inst., enclosing sketch and connecting lines showing excess of 118 varas E. and W. between Survey No. 18, Block A, H.E. & W.T. Ry. Co. and Survey 1, Block 9, T.W.N.G. Ry. Co. in Schleicher County, also two working sketches and a certified copy of connecting lines heretofore furnished you by this department, covering the same territory, and asking this department to advise you concerning the disposition of said excess and construction of other surveys, etc.

The field notes of survey No. 1, Block EEE, G.C. & S.F. Ry. Co. covering the space between said surveys Nos. 18 and 1 call to begin at a rock mound made for the N.E. corner of Survey No. 18, Cert. 11, Block A; thence E. 1900 varas to a rock mound made for the N.E. corner of this survey and N.W. corner of Survey No. 1, Cert. 0/376, Block 9, T.W.N.G. Ry. Co.; thence S. 1900 vrs. to rock mound made for S.W. corner of Survey No. 1, Block 9; thence W. 1900 varas to rock mound made for N.W. corner of Survey No. 16, Block A and N.E. corner No. 17 and S.E. corner No. 18, same block; thence N. 1900 varas to place of beginning. Rock mounds alone without marks or bearings by which they can be identified are very uncertain; therefore, in this case, unless the rock mounds called for can be identified the calls in the field notes of No. 1, Block EEE will cover all the land E. and W. between said surveys No. 18, Block A and No. 1, Block 9.

In reference to Survey No. 16, Block A, and Nos. 14, 12, 10, 8 and 6, in same tier extending S. in Block A, all being school surveys and shown by maps and plats in the General Land Office to join the West line of Block No. 9, under Acts of 1889, page 104 (See same in Arts. 5396-7 & 8, Revised Civil Statutes of 1911) they will take and include all excess, if any, up to the W. line of said Block No. 9. In like manner No. 16, Block A, would include all space up to the S. line of No. 1, Block EEE, and have common corner with Survey No. 2, Block 9.

Herewith find sketches and copy of connecting line returned.
