The below
is the correct field notes of the
South & East boundary lines of
Block 97. H. & T. C. R. R. Co. Survey in Sevier
Co as found by actual Survey on
the ground. to wit:
I found the S.W. cor of Sec 84 137.
97. an old rail pile from which an old oak
Live Oak 24" bro N 24° E 11 rods. (not N 24° W)
From thence I ran East. (Variation 10° 15' E)
at 1885 rods turned South 40 rods to S.E.
Cor of 84 from which an old oak H by
bro S 36° 160 rods. From thence ran East
1886 rods S.W. cor of 82. from which an old
oak H by in cluster bro N 29° 4' W 540 rods
do. bro N 3 1/2° E 785 rods. Thence East
at 1838 rods an old stake the S.E. cor of
82. from which an old oak mes 2"
bro S 2° W 8 rods do 4" bro S 14° W 20 rods. from
which point Munchagua Peak in Boone Co.
bro N 60° 20' W.

From thence I ran North at 2 miles 937 rods
cross Colorado River at 4 miles 1662 rods
cross Canon Creek (S 55° E) at 5 miles an
old stone mes from which an old oak H by
bro S 65° W 28 rods Thence N. at 6 miles found
an old stake the N.E. cor of N^o 135 from which
an old oak mes 6" bro S 67 1/2° W 81 rods. at 11 miles
found the old N.E. cor of 172 - a stake & stone
mes in the East edge of a H by thick with
an old line cut out through it in both
counter 36560

directions at 18 miles 580 ovs. cross Dup cr
 at 19 miles 1540 ovs turned West at 1 mile
 the old. NW cor of N^o 338 with bry. a called
 for at 2 miles found an old stone me^a
 from which an all west^e Cotton wood bro
 S10 E 365 ovs. (not S10 W) to an elm grove bro
 S56 W. (not on Cotton wood face N10 W)
 From thence went to NW cor of 338

to ran N one mile & found NW cor
 of N^o 339 with bry. as called for.
 Thence East at 790 ovs cross Culvers
 Creek (C.S) at 1900 ovs made stone
 me^a & took the following bearings
 a mes. 6" bro S16 1/4 E 60 ovs mes. 8" bro
 S37 ovs 127 ovs. I found that to get
 a course to run this line required
 a variation of 9° 21' E or 10° 24' W
 variation than the H & N R & Co. on
 the East runs at which is 10° 45' E.

 Block 97 to actually be.
