Report of a resurvey of survey No. 628.
Starr County, Texas.

Object of survey, to determine by actual survey on the ground the true lines and acreage of said survey 628.

Surveyed on the application of Mrs. O. H. Davenport, Owner of said Survey.


After examining the records of survey 628 and adjoining surveys, I went to a post at corner of fence in the north line of survey 627, as found by Mr. R. I. Parks in his survey of 627, said post being the South corner of survey 13, the S.W. corner of survey 751 and the S.E. corner of survey 749, thence running N. 88-30' W. 304.2 vrs. to a corner of fence, the S.E. corner of 615 and the S.W. corner of 749, thence continuing with fence and north line of 627, N. 81-30' W. 173.5 vrs. to an old post Mkd. M. P. A. 1907, the N.E. corner of survey 626 and N.W. corner of 627, Thence running with fence S. 8-25' E. 782.7 vrs. to an intersection with the North line of Porcion No. 80, as partitioned by Dist. Court, in 1926. I set a post for the S.E. corner of 626 and a corner hereof; Said post being 1199.2 vrs. S. 80-40' E from a post the N.W. corner of Porcion 80, From said post and S.E. corner of 626, I ran N. 8-25' E. 571.5 vrs. and set a post for the N.W. corner hereof; and S.E. corner of 627, thence S. 80-45' E 1850.8 vrs. to a 4" pipe 4' high, a corner of 627 and a corner hereof; Thence S. 9-15' W. 828.0 vrs to a post set for the N.W. corner of 12, for a corner hereof; From whence a Mesq. Mkd. three hacks on the East side Brs. N. 44-30' W. 6 vrs. thence with West line of survey 12, South 950.4 vrs. set a post for the S.E. corner of 12 and a corner hereof; Thence East with the South line of 12, 950.4 vrs. set a post for the S.E. corner of 12 in the West line of 21, for a corner hereof, thence with the West line of 21, South 394 vrs. set a post for the S.W. corner of 21 and a corner hereof; thence with the South line of 21, East 1344 vrs. found an Iron pipe down (I reset it) the S.E. corner of 21, a corner of 627 and a corner hereof; thence S. 80-45' E.

8.3 vrs. set a post in the West line of survey 89, the S.E. corner of 627 for a N.E. corner hereof; said post being S.9-03'W.2438 vrs. of the N.E. corner of survey 627. thence S.9-03'W.820.8 vrs. to an iron pipe, from whence a Mesq. Mkd. X brs. N.72-00'W.2033 vrs, another S.82-00'W.16.6 vrs. said Pipe being the S.W. corner of 89 and N.W. corner of 933, as set by myself in 1935, Thence with the West line of survey 933, S.9-15'W.2589.6 vrs. to an Iron pipe, from whence a Mesq. Mkd. X brs. N.17-00'W.22.7 vrs. another N.86-30'E.18.4 Vrs. said pipe in the North line of Porcion 83, the S.W. corner of 933 for a corner hereof;

Thence with the North line of Porcion 83, N.80-45'W.108.4 vrs. to a post for the N.W. corner of said porcion, thence S.8-59'W.116.1 vrs. to an iron pipe in corner of fence, the N.E. corner of porcion 82 as partitioned by Dist. Court, in 1944, thence with the North line of Porcion 82, N.80-45'W.1300 vrs. to an iron rod in the East line of porcion 81, the N.W. corner of 82 for a S.W. corner hereof; thence with the East line of porcion 81 as partitioned, N.9-00'E.2738.4 vrs. to a large stone, the N.E. corner of porcion 81 and a corner hereof; thence with the North line of porcion 81, N.80-43'W.1322 vrs. to a pile of stones in the East line of Porcion 80, being the N.W. corner of porcion 81 as partitioned, thence with the East line of porcion 80, N.9-06'E.2000.9 vrs to a post for the N.E. corner of porcion 80 as partitioned, thence with the North line of Porcion 80, N.80-40'W.1586.7 vrs. to the post set for the S.W. corner hereof;
