now Sir: Herewith I send you sketch showing relative positions of survs 1307-36, 1401-37 and Sec. 12 Twp 5 N. R. 10 E. as shown by the ~~map~~ corners and lines marked on the sketch as "~~corners~~" "Corners", line marked &c. The NW & NE corners of 1420 are found exactly as described in field notes, which locates this survey one block i.e. 1225' or east of position given there on the map. Also the N. corner of 1408 are found at positions shown on sketch. The N. corner of Sec. 12 Twp. is found to be 7 1/2' or 5' or 4' or 3' of the common N. cor. of 1420 & 1421. She witnesses true that the field notes of 12 describes as being N 9 1/2' E 7' or is the one that the Colony field notes describes as being S 6 1/2' E 5' or, it being moved as a bearing to both corners. She

N. W. cor. of 14 70 has both its bearings standing also. R. A. McNelly a former county surveyor examined all these surveys fully and made sketch and submitted a report upon authority of which that office ruled that section 12 was correct as shown by enclosed sketch. In view of these facts Mr. Elisha Norris who some time ago asked that his purchase of the N. E. 1/4 of sec. 12 be cancelled and money refunded.

The northeast cor. of sec. 13 blk 5 was found to be identical with the S. E. cor. of 1332 & N. E. cor. 1331 N. E. of d. l. e. — Surveys 1301 to 1336 seem to have been surveyed without turning off. The variation of the needle — that is east & west. The lines running N. 0. 5. appearing to be nearly right.
