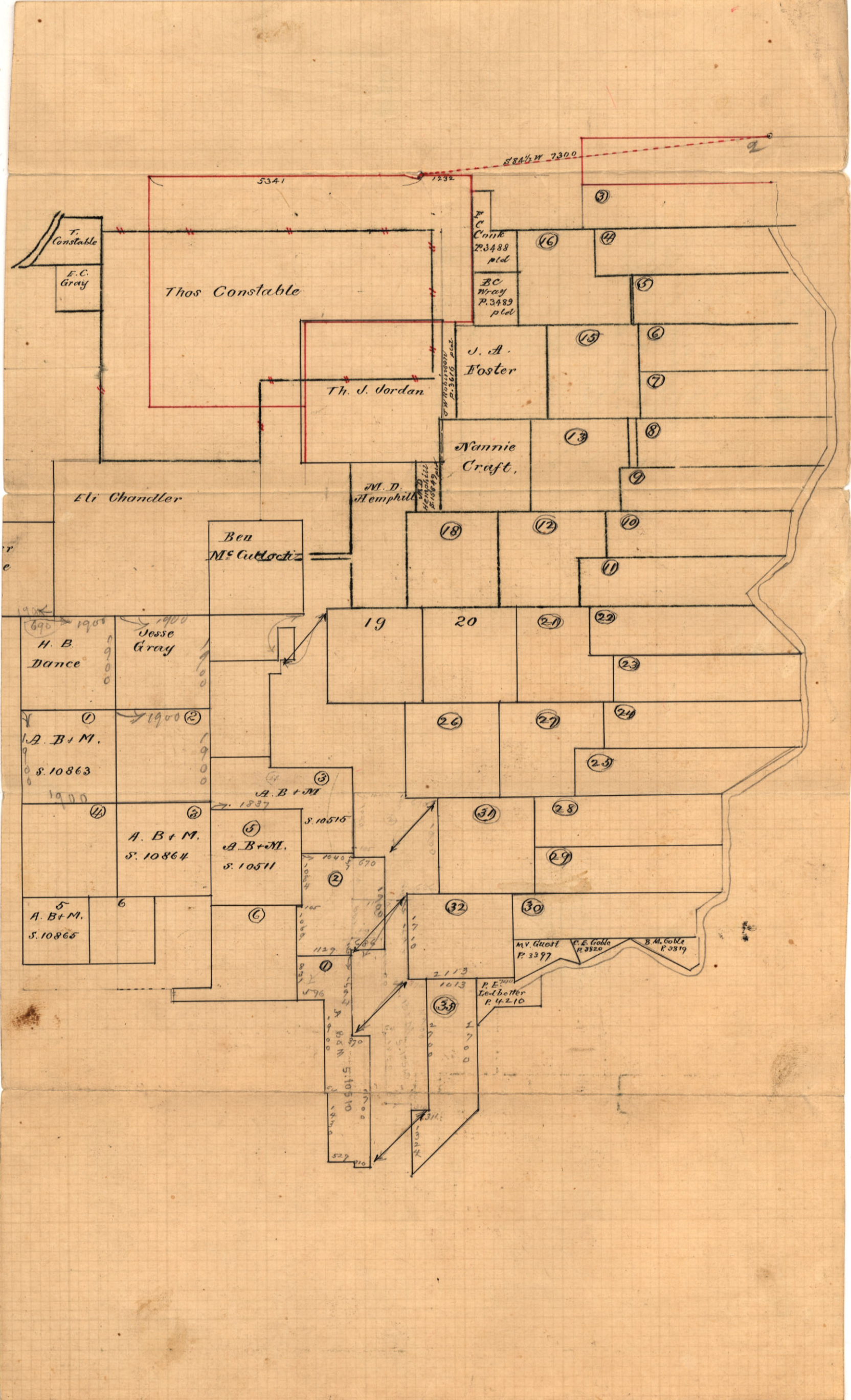

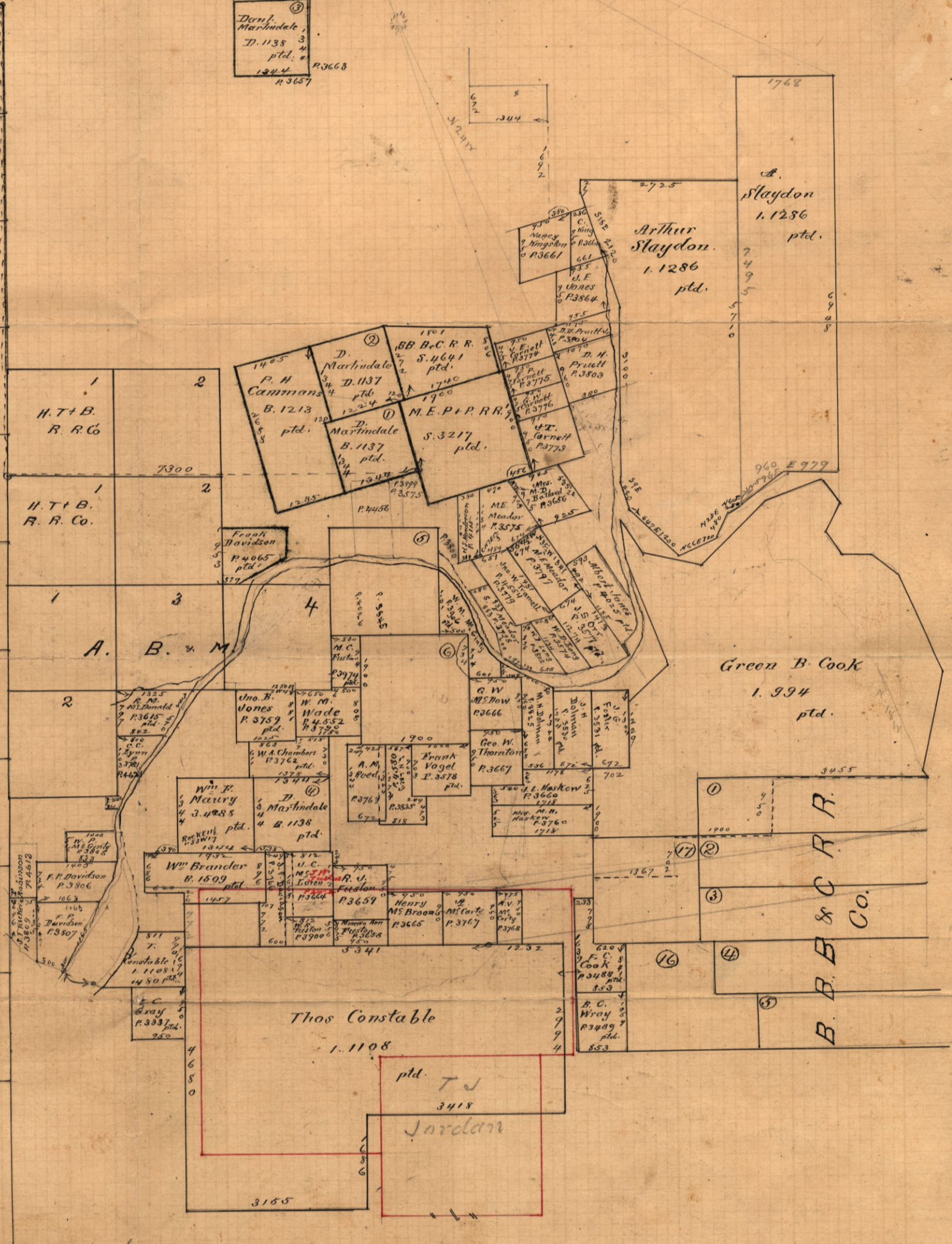


The red lines show the boundaries of the Constable according to Decease of Court.
