Subject: Construction of the following blocks in Pecos and Terrell Counties, which were originally surveyed by H. C. Barton in 1881, and re-surveyed by J. A. Simpson in 1929 through 1936: T.C. R.R. Co., Block A-2; C.C.S.D.&R.G.N.G. R.R. Co., Block B-2; E.L.&R.R. R.R. Co., Block C-3; and G.C.&S.F. R.R. Co., Block C-4.

In compliance with a request received from Clifford C. Cool, dated September 12, 1960, for instructions from this office as to the proper method of locating the boundary lines of the sections in the captioned blocks, a conference was held with the Legal Department and the Engineering Department to study the matter.

It now appears from an examination of all the Land Office records pertinent to the area that the map filed in this office in 1936 by J. A. Simpson, known as Terrell County Rolled Sketch "JAS", represents the construction of the Barton blocks which should be followed, based upon the corners which are identified by witnesses.

This construction has been recognized by the Land Office for more than twenty-four years and patents and deeds of acquittance have been issued on the corrected field notes of J. A. Simpson compiled in accordance with the "JAS" map. The Land Office has been informed that all land owners in the area recognize this re-survey and are holding their property accordingly, and that injustices would occur by a reversal of opinion and the rejection of the Simpson survey at this late date.

It is also to be noted that the variation used by Mr. Simpson in his resurvey of the Barton blocks was the variation used in the Whiteside, Turner and Douglas Oil Company cases for Blocks A-2 and B-2.

It is, therefore, the concensus of opinion of those conferring that the Land Office should continue as heretofore to accept corrected field notes for the issuance of patents and deeds of acquittance based upon the construction reflected in the Simpson map.

I am considering doing survey work in Pecos and Terrell Counties in the four blocks laid down by H. C. Barton in 1881, namely: T.C. R.R. Block A-2, C.C.S.D.&R.G.N.G. R.R. Co. Block B-2, E.L.&R.R. R.R. Co. Block C-3 and G.C.&S.F. R.R. Co. Block C-4. The purpose of this work is to locate and prepare corrected field notes on those sections not yet patented and also prepare corrected field notes on certain patented sections which contain excess acreages in order to purchase the excess.

I have made a study of the General Land Office records regarding the original and subsequent survey work in these blocks. This study raises several questions as to the proper method to be used in re-establishing the boundary lines of sections in these Barton blocks. Before submitting these questions for your consideration I will outline briefly the results of my study of the General Land Office records.

In 1881 H. C. Barton surveyed Block A-2 (100 sections), Block B-2 (80 sections), Block C-3 (20 sections) and Block C-4 (64 sections), embracing in all 270 sections. More than half of the 270 sections were patented on Barton's original field notes. Barton called most of the section corners to be stakes and mounds, however at some corners he called for "stone mounds" or "pile of pebbles". Some of the stone mounds had witnesses. Others called to be stone mounds in valley or on side of mountain, while none of the pebble corners were witnessed. Only nine of the stone mounds Barton called for had witnesses, while the remaining 24 stone mounds and seven pebble mounds were without witnesses. All nine of the witnessed stone mounds were in the

east and north part of Blocks A-2, C-3 and C-4 with the most northwesterly one being at the northwest corner of Section 3, Block C-4.

In report dated August 13, 1929 (File No. 29-B, Pecos County) Mr. J. A. Simpson reported that he had found practically all of Barton's original stone or pebble corners in Blocks A-2, C-3 and C-4. However only five of these corners had witnesses, the balance being just stone or pebble mounds. In this report Simpson stated he had previously found Barton's original northeast corner of Section 43, Block A-2, which Barton witnessed. As result of his 1929 work Simpson submitted a sketch (CSF 11690 filed in General Land Office, July 9, 1929), showing his work in the most southwesterly part of Block A-2 and another sketch (File No. 29, Pecos County, filed in General Land Office, August 2, 1929), showing his work in the western part of Block A-2 and in the central part of Block C-4. This latter sketch was endorsed by the General Land Office as follows: "This construction of surveys in Blocks C-4 and A-2 not accepted by Land Office. Surveys in Block Z appear O.K. 9-16-29. Mc" In a letter dated 9-6-29 from the Acting Land Commissioner to E. B. Chandler and Company, the following excerpt is taken:

". . Mr. Simpson's plat and corrected field notes are at such variance with the records of this office that the office hesitates to approve same without further information from Mr. Simpson in regard to his findings and identification of corners on the ground. It is noted on his plat that he marks several of the corners "H. C. Barton" which would indicate that he recognizes such corners as original made by Mr. Barton, the locating surveyor. But inasmuch as there seems to be no description of said corners in the field notes by Barton by which said corners can be identified by bearings of any kind there would seem to be some doubt as to accepting points short of course and distance as called for in the original field notes. Mr. Simpson's work would seem to cause a general disturbance in the location of surveys in Block C-4 . . "

I find no record of patents having been issued on Simpson's corrected field notes based on his 1929 work. It would appear that the Land Commissioner was reluctant to accept unwitnessed or unidentifiable stone mounds as being original Barton corners. Proof of this is demonstrated by Mr. Simpson's subsequent work in 1936 and depicted on Terrell County rolled sketch "J.A.S." filed in the General Land Office, September 22, 1936. As a result of Simpson's 1936 work 21 or more unpatented sections in Block B-2 were patented on his field notes and at least four sections that had been patented on Barton's original field notes were issued deeds of acquittance. In Block A-2 at least 31 sections were patented and 11 deeds of acquittance were issued based on Simpson's 1936 work. In Block C-3 at least three

sections were patented on his field notes while in Block C-4 at least 25 sections were patented and at least 70 deeds of acquittance were issued on Simpson's 1936 field notes. It is interesting to note that on sketch "J.A.S." the northwest corner of Section 3, Block C-4 is the most westerly corner that Simpson designates as original.

Out of the 270 sections in these four blocks at least 112, or almost half, have either been patented or issued deeds of acquittance using Simpson's 1936 corrected field notes. In his 1936 work Simpson accepted only identifiable or witnessed corners as being original Barton corners which corners Simpson used to control the location of the sections depicted on sketch "J.A.S."

At the present time there are some unpatented sections in nine of these blocks but the exact number I do not know.

Trusting that the foregoing has given you a clear picture of what has gone before, I would appreciate your advising me at your earliest convenience which of the following methods I should use in locating the boundary line of Sections in these four blocks:

- Should I disregard Simpson's 1936 work and use the unwitnessed corners in the western portion of these blocks as being original Barton corners?
- 2. Should I follow the construction shown on Simpson's sketch "J.A.S.", thereby conforming to past acceptance by the General Land Office?
