## -REPORT-

The Land Office desires to know where I started in making the surveys herewith submitted and how I knew that I was at Double Lake's corner.

In the spring of 1902/I was first there I found an old earth mound with ciruclar trench around the same about ten or twelve feet in diameter. It showed to be an old corner at that time, in fact if there be any other corner between the lakes I did not find it and I spent time diligently looking for others while on the ground. From which corner the west edge of East Lake bears E 605 varas. The nearest point to East Lake is 570 varas. The end of East Lake is 700 varas; and from a point East of said corner the Lake's South end is approximately 400 varas. The N E edge of West Lake 530 varas; West 353 varas; a gulch South of West Lake South  $40\frac{1}{2}$  W about  $1\frac{1}{4}$  miles; a stone pile placed South  $27\frac{1}{4}$  E;  $91\frac{1}{2}$  varas. The center of a small island in West Lake South  $33\frac{1}{2}$  West - the soil at corner is grayish white fine sand, like ashes, easily eroded.

Beginning again at same point which now has iron pipe and pine stake in same, then by running North, (variation 11 degrees, 12 min. East) passing over corners at 1, 2, 3, 4, and 6 miles, 12 miles North and 12 miles West, I reached the N E corner of No. 2 and the N W corner of No. 1, Block E. However, I ran North 6 miles, west 12 miles and North 6 miles to same point, which point is the South line of what is known as the Strip. Then measuring across North from said Block E line to the South line of Donley County School League 3080 varas I reached South line of said League, which point I determined by running East from the original S W corner of said School Land League.

I checked the South line of Donley County School Land No. 9, running west recovariation 11 degress 8 min. east to the original S W corner of said League, which is an earth mound with iron pipe in same. I ran North 420 varas to a point an iron pipe S E corner of League No. 11; thence west checking the South line

of same, variation 11 degrees and 1 minute east, passing over the original S W corner and extending the same line variation 11 deg., 05 min. to the S W corner of McCullough County School Land League No. 22; thence South 420 varas to an iron pipe, the S E corner of League No. 23; thence west variation the degrees East to the S W Corner of same, an iron pipe driven for corner; thence South 693 varas to the S - sorner of No. 36 Zavalla County School land, an iron pipe corner; thence west variation 11 degrees 15 min. to the S E corner of League No. 35; thence West variation 11 degrees, 37 min., to S E corner of No. 37, thence west 11 degrees, 24 min., East past old league corner, wagon thimble set in same, S E cooner of No. 38, Zavalla County School Land; thenge West variation 11 degrees, 39 min., East past old corner with iron pipe set in same to S E corner of No. 52; thence West variation 11 degrees, 44 min. East past the old S W corner of League No. 52, an earth mound and sucker rod in same for corner, also the S E corner of No. 51, Scurry County School Land; thence west variation 11 degrees, 41 min. East to an iron pipe set for the S W corner of same.

I then began at the N E corner of the John Bibson Block, Section No. 22 and ran North to intersect the South line of the last above mentioned league and fint the distance to be 2907 varas.

I then ran the North line the Block E, 4X, and D 14, on a variation of 11 degrees,55 min., East, passing over or rather about 2 varas North of a pipe driven by Nelson K. Smith for the N W corner of Section No. 28B, which line I continued on the above variation stated, to the end of Block X.
