Dear Sir:

I enclose corrected field notes for Survey No. 781 in Kinney and Uvalde Counties and corrected notes for Survey No. 782 in Kinney County with sketch showing these and other surrounding surveys.

In 1923 I sent in corrected notes for Survey No. 781, showing acreage of 1011, and you will find sketch showing how the Eastern lines of 781 were located, which I have since checked and found correct. I afterward determined from work on the ground that Survey No. 782 does not lie on the ground as its original notes call.

In connection with other papers I give below actual survey on the following connection lines:

lst. Beginning at an old Live Oak line tree on the South line of Survey No. 720 called for in the original field notes of said Survey. Thence S. 80° W. 200 vrs to the original lower S.W. corner of Sur. No. 720. Here I found three L.Os., the middle one with plain marks, X; the rk.md, being in a draw is gone, as is also the other bearing tree, a L.O. 3", N. 84 3/4 W. 31.8 vrs. Thence N. 20° E. at 328 vrs found old rk. md., the original N.E. corner of Sur. No. 19, found both bearing trees, a L.O. now 8", 1½° E. 8.2 vrs. do 10" S. 51 3/4 W. 10.2 vrs., 788 vrs. Thence N. 70° W. 1107 vrs to an old rk. md, the original S.E. cor. of Sur. No. 72. Thence N. 20° E. 1015 vrs. to a Cedar 3" in dia. the original N.E. corner of Sur. No. 72. This Cedar shows plain marks and has rk. md. around it. Thence N. 70° W. at 10° vrs., a perpendicular bluff at 278 vrs. point in L.O. Creek. Thence N. 20° E. 672 vrs. found a rk. md. on side of a mountain, the N.E. corner of Sur. No. 74. Thence N. 70° W. 494 vrs. Thence N. 20° E. 1772 vrs. Thence N. 70° W. 1900 vrs to an old rk. md. the original N.W. corner of Sur. No. 667; this corner is on the North side of a hill that forms a bluff on E. side of Live Oak Creek, where Cherokee Creek enters it. A peak brs. N. 68½ W. and two more bear S. 76½ W.

2nd. Beginning at the N.W. corner of Sur. No. 667 as described above, thence S. 70° E. 872 vrs set rk. md. Thence N. 20° E. 1960 vrs to an old rk. md., the original N.E. corner of Survey No. 723, and the N. W. corner of Sur. No. 724. Thence

N. 70° W. 800 vrs. found original designation point on North line of Sur. No. 723, a L.O. 9" on line, a L.O. 6" S. $3\frac{1}{2}$ W. 5.2 vrs., do 5" S. 6 3/5 vrs. all plainly marked.

3rd. Beginning at N.W. corner Sur. No. 724. Thence S. 70° E. at 1900 vrs. set a large rk. md. in a draw for the N.E. corner of Sur. No. 724, 2271 vrs. set a rk. md. marked a L.O. 6" S. 88½ E. 28 vrs. do. 8" N. 44° E. 38 vrs. Thence South 367 vrs. set a rk. md. Thence East 76 vrs set a rk. md. for N. W. corner of Sur. No. 783 marked a L.O. 6" S. 78 E. 8½ vrs. do. 6" S. 62 E. 8 vrs. This corner was set by me, N. 20° W. 600 vrs. and S. 70° W.1445 vrs. from the original N.W. corner of Sur. No. 661 (See former sketch in connection with corrected notes of 781).

You will note that I have lengthened the East line of Survey No. 720 to 2310.6 vrs. This was done to conform to the passing call in its notes for the N.E. corner of Survey No. 72, which is a well known and long recognized land mark. This construction will split 780 in two pieces. The N.W. one-fourth of 720 was run and fenced on the ground as shown on the enclosed plat and since the shape of 720 is so materially changed its other subdivisions, which have been sold, should be corrected if patent has not yet issued.

Will you kindly advise me what action you take on this matter.
