My dear Commissioner :--

In connection with a re-survey on the ground of original survey No. 1014, Medina County Schood Land, lying and being situated in Medina and Uvalde Counties, I beg to submit the following data showing work done on the ground.

I located the original S. E. corner of 1014; found rock mound and bearing tree, a L. O. 20" N. 37 W. 39 vrs. dead but standing. Made new bearing, a L. O. 24" dia. N. 4 W. 42.5 vrs.

Thence ran a line West and checked into N. W. corner No. 101 and N.W. cor. NO. 102, both of which corners I located and bearings recorded on accompanying Plat as found. At 4180 vrs. a 24" L.O. mkd. \equiv stands three feet south of line. Marks very old. At 4335 vrs. a rk. md. in line fr. wh. a L. O. 24"-plainly marked- brs. N. $9\frac{1}{2}$ °E. 76 vrs. At 5000 vrs.-Patent Call- searched for corner and bearing trees, found nothing. At 5156 vrs. a fence corner. From here I ran a line south and found rk. md. the S. E. corner No. 103 and S. W. corner No. 1040. Bearing called for here not found. All older timber dead.

I located the original N. W. corner of survey No. 1014 on the ground. A L.O. now only a 15 inch dia. stump standing, brs. N. $62\frac{1}{2}$ E. 46.2 vrs. and a L. O. 18" dia. brs. N. $58\frac{1}{2}$ E. 39 vrs. Also located the original N. E. corner of survey No. 105, distant 185 vrs. east and 39 vrs. south of the N. W. corner No. 1014. Both trees standing and plainly marked.

From N. W. corner No. 1014 I ran a line south and at 5296 vrs. and at 5156 vrs. intersected south line of No. 1014, brought from original S. E. corner of same. Established here true S. W. corner No. 1014.

From the N. W. corner No. 1014 I ran a line east and located the S. E. corner of survey No. 343, and the S. E. corner No. 344 with bearings as marked on the accompanying sketch.

I located on the ground the original N. E. corner of No. 1014 and S. E. corner No. 1015, a L. O. (original) 36" dia. brs. S. 54°W. 70 vrs. and a L. O. 8" brs. N. 15°E. 25.2 vrs. and ran line to same from S. E. corner of survey No. 344 as shown on plat and field notes. Course of line to connect corners N. 894°E.
