Dear Sir:-

While at the Land Office last month Judge Clark, advised me that he wanted a report showing what I found on some surveys I made of the H.C. Yeager lands in the north east part of this county, and partly in LaSalle and Duval Counties as shown by a map of the survey I left in the land office at the time.

The following is the report of the survey:-

The south line of surveys 52, 51, A B & M., is well ~~defined~~ defined, by a fence line and I found the stone corners of same, as well as the south west corner of survey 346 A B & M., and its south east corner these corners were the original of these surveys and are still very evident on the ground.

I also found the four corners of survey No. 53 A B & M., and the two south east corners of survey No. 94 L. I & A. A. These being the original corners of said surveys; The west line of survey No. 94 L. I & A. A. is well defined being an old river survey No. 96 Joseph House.

~~xxxxxx~~ The original corners of surveys 41 J. Poitevent and survey 38 T. B. Haynes, are still on the ground and are mezquite posts, and stones, all of the corners of 38 are well preserved and still exist.

The north east line of survey 110, Henry Sykes, is an old fence line as I stated to Judge Clarke, and runs out from the river, it continues on and becomes the north east line of survey No. 38, This survey No. 110 has stones for its east corner and also for its south corner serving as the corners of survey No. 38. Surveys Nos. 94, T. H. Hall, 95 J. Gilliard, T. T. Doswell, had nothing on the ground to show that they had ever been located, but with the surrounding surveys No. 96 J. House, and 110 H. Sykes, I was able to locate these surveys as well as 37, 39 J. H. Gibson, by their course and distance and their boundary line the Nueces river.

You will note from the map I sent in of this work that all of the surveys mentioned are a little short of acreage and some have a small excess; I was instructed by the Land Office to make corrected field notes of these surveys and send them in with a map and report, in order that Mr. Yeager may have a new abstract made and get a reduction on his taxes which he has been paying on the above land being almost 1000 acres short of what he should have. The map and corrected field notes are already in; this is a true and correct report of the work and trust that there will be no further delay in having this matter arranged. The survey was made with extreme care and all of it closed within a minute on my transit, and the map of the work shows it exactly as I found it on the ground.
