Dear Sir:-

Your letter to Messrs. Mann & Mann regarding surveys 211 & 212 handed to me and contents noted.

In paragraph (5) of your letter you state that you cannot tell if the south lines of surveys 211 & 212 and north lines of 283 & 284 that apparently encroach on surveys 1701-1702-211 & 212 are correct; "ties" to creek & the accepted corner of survey 283 from stone found on ground and shown on sketch as being the S. E. corner of 212 show that an old fence (built in A. D. 1898) and running from a point on the south line of sur 211 to a point on the E. line of survey 251 is on the survey line.

To further show that the position of the lines mentioned in my notes are correct I have made a sketch which enclosed you will find showing "ties" to surveys 251-2194- 1507 & 2065 that show or prove conclusively that the fences shown were built on the original survey lines.

In our region or territory we generally find the fences on survey lines and fence corners at survey corners.

If any further explanations are required please advise.
