 bearing trees of the J. M. Gresham and J. T. B. Haynes,
 were lost said corner now being in the river, and
 that I run West 1444 rrs and South 1180 rrs and
 found the double Elm called for at the upper corner of
 the Haynes & lower corner of the Loyd, surveys, that
 one fork of said Elm is plainly marked and that the
 other is down, That from the lower corner of the
 sd J. M. Gresham I run North 5537 rrs. his N.E. Cor
 and the S.E. Cor of Tarrant Co. S.L. Thence N 7142 rrs
 sd School Lands N.E. Cor, and the S.E. Cor. of Sec N^o 1
 C.T. R. R. Co. Sur. Thence N 1900 rrs its N.E. Cor and the
 S.E. Cor of state Section N^o 2. same Co. Thence N. 1900. rrs
 its N.E. Cor; and S.E. Cor of S.A. M. & G. R. R. Co Sur
 N^o 1 Cert N^o 21/214, Thence N. 1900 rrs its N.E. corner
