tree not very plainly marked, and that I run
West 1444 rods. and 763 rods North. and found that the
bearing trees of the J.W. Gresham and J.T.C. Haynes,
were lost said corner now being in the river, and
that I run West 1444 rods and South 1180 rods and
found the double Elm called for at the upper corner of
the Haynes & lower corner of the Loyd. surveys. that
one fork of said Elm is plainly marked and that the
other is down. That from the lower corner of the
sd J.W. Gresham I run North 5537 rods his N.E. cor
and the S.E. cor. of Tarrant Co. S.L. Thence N. 7142 rods
Sd School Lands N.E. cor. and the S.E. cor. of sec No 1
C.T.R.R. Co. sur. Thence N. 1900 rods its N.E. cor and the
S.E. cor of state section No 2. same Co. Thence N. 1900 rods
