## Statement.

The leagues of Jacob Eberly, Willis Avery and Jesse Barker, titled in 1832, were originally illegal because made outside of the limits of S. F. Austin's Colony but were confirmed by the act of the Legislature of Febr. 2<sup>nd</sup> 1854.

Previous to said confirmation these leagues had been partly located over and by a Decree of the District Court of Williamson County N<sup>o</sup> 12. Morgan C. Hamilton vs Willis Avery, said grant was declared void, March 9<sup>th</sup> 1858.

Febr. 16/58. an act was passed for the relief of Willis Avery, the heirs of Jesse Barker, the heirs of James Smith, the heirs of Jacob Carsner and the heirs of Jacob Eberly (all of them owners of grants in said block) authorizing the Commissioner of the General Land Office, to issue to each of them a Certificate for one league of Land.

Jacob Eberly has on the Certificate so received 3 surveys ptd in Karnes County and four surveys in Montgomery Co. see Solid 1-302 and Montgom. 1-553, 559 & 560. 1

Willis Avery has a full league ptd on his Certificate in Kendall Co. <sup>(which covers not the full amount)</sup> see Travis 1-422 in Bastrop, Lee, Fannin, Hunt and Grayson Counties

Jesse Barker has the full amount of a league ptd, see Bastrop 1-586, Washington 1-30 and Fannin 1-1351, 1353, & 1360.

Jacob. Carsner - full amount ptd. See Milam 1-1593 and Bowie 1-270, 276 & 279.

James Smith - full amount ptd. See Robertson. 1-1099. Navarro County.
