KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, The Leon and H. Blum Land Company, a Corporation duly incorporated under the laws of the State of Texas, L. Fellman, Dr. Edward Randall and The Island City Savings Bank, all of the State and County aforesaid, were the owners and holders of a number of land certificates issued to John H. Gibson by the Commissioner of the General Land Office, on the 16th day of July 1877, by virtue of and in accordance with the provisions of an act to improve the navigation of Oyster Creek, San Bernard River and Caney Creek, approved March 15th, 1875, the Certificates owned by the parties above named having been duly located in Yoakum and Terry Counties, State of Texas and filed notes properly filed in the Ceneral Land Office at Austin; and

WHEREAS, suit was instituted by the State of Texas against the above named parties, jointly as defendants, to teste the valifity of said certificates, and the locations thereunder, said suit having been brought by agreement in the District Court of Travis County, Tex. and,

WHEREAS, on the 23rd day of December, 1893, in Cause No. 12,293, styled The State of Texas, Vs. The Leon H. Blum Land Company et al, judgment was rendered in the 26th Judicial District Court of Travis County, Texas, Judge R. E. Brooks presiding, decreeing and vesting title in the defendants to two hundred and forty-six (246) Sections of land out of the whole number of odd numbered sections located as aforesaid, upon the public Domane of the State of Texas, by virtue of Certificates issued on account of work done on the San Bernard River, giving said Defendants the priviledge and right to select their two hundred and forty six sections, the decree further providing that nothing contained therein should be held to determine or affect the rights or equities of the said defendants themselves concerning which they, or any of them, may proceed when and how they may be advised, and WHEREAS, The Defendants in said numbered and entitled cause within the time allowed did select two hundred and fortysix sections of land which two hundred and forty six sections are fully set out and described in the decree aforesaid and to which decree, or a certified copy thereof duly recorded in the Deed Records of Yoakum and Terry Counties, Texas, special reference is here made for further particulars, and

WHERLAS, at the time said decree was rendered the two hundred and forty six sections above refered to, were owned as follows:

WHEREAS, in February 1899, a designation in writing covering the 246 sections above referred to, together with one hundred and four (104) transfers of Certificates with the name of G. Mussbaum inserted therein, eighty four transfers of Certifi-cates with the name of The Leon and H. Elum Land Company inserted therein, thirty four transfers of Certificates with the name of The Island City Savings Bank inserted therein, and Transfer of One Certificate with the name of Dr. Edward Randall inserted therein, were filed in the General Land Office at Austin, for the purpose of having patents issue. Transfers of twenty three additional certificates belonging to Dr. Edward Randall having been destroyed by fire, (said twenty-three sections being properly designated for said Randall in said designation of writing) patents to issue as the rules of the Land Office may require, At the time of the burning of the Twenty-three transfers in question, John H. Gibson was dead and the deed from Fannie MccAlpine Gibson, wife of John H. Cibson and other heirs of said John H. Gibson to D. Edward Mandall, dated April 20th, 1882, is filed for record in Volume One Pages 3 to 6 inclusive of the Deed Records of Yoakum County, in Eartin County, Texas, and to which deed, or the record thereof reference is here made; and

WHEREAS, L. Fellman and N. Grumbach, on December 30th, 1896, executed a Deed of Trust to <u>Isac</u> H. Kempner, Trustee, conveying all John H. Gibson Certificates and the land thereunder owned by the said L. Fellman, said Deed of Trust being recorded in the Deed of Trust Records of Yoakum of Yoakum County, Texas, in Book No. One, Pages 1 to 18, inclusive, and
