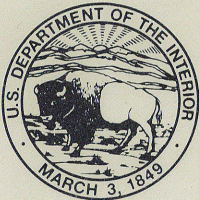

The following field notes are those of the survey of the lands of the Tigua Indian Reservation-Ysleta Del Sur Pueblo, El Paso County, Texas.

The boundary of the lands of the Tigua Indian Reservation-Ysleta Del Sur Pueblo (TIR) were constructed from deed descriptions and surveys on file at the El Paso County Courthouse, El Paso, Texas. The descriptions and surveys, together with all their courses and distances and all calls for monuments, form the basis for this survey and are considered sufficient to delineate the boundaries of the TIR.

The survey was executed in accordance with the specifications as set forth in the Manual of Instructions for the Survey of the Public Lands of the United States, 1973, and the Special Instructions for Group No. 4, Texas, dated April 28, 1993. In addition, this survey was conducted according to the methods, principals and procedures of land boundary surveys of the State of Texas.

Before establishing the properties, the lines of the deed descriptions and surveys of record were retraced and a thorough search for any evidence was made. Boundaries were determined from existing local monuments, man-made features, and or topography where such evidence was available. Corners with no suitable evidence of previous surveys or location were established by the appropriate method of proportionate measurement between the nearest related calls and/or accepted controlling corners.

The lands acquired by the TIR and surveyed herein consists of seven separate tracts throughout El Paso County, Texas. These tracts and their descriptions are as follows:

Housing Development Tract:

Block 49, Ysleta Grant, portion of Tract 3A, all of Tracts 3B, 16B, and 17C, as per Warranty Deed dated April 26, 1972. Tract 16A, as per Warranty Deed dated July 19, 1972. Tract 15, as per Warranty Deed dated October 6, 1977. Tracts 18B and 18D, Warranty Deed date unconfirmed. Note: Tract 18A as listed on the deed is in error.

The direction of the lines of this survey were determined by direct solar hour angle observations and refer to the true meridian. The lines were carried forward by sustained angulation, being supplemented by other solar hour angle observations taken throughout the progress of the survey. All lines were measured with an electronic distance measuring instrument, and lines not forming a closure were confirmed by double measurement.

G E N E R A L D E S C R I P T I O N

The lands encompassed in this survey are those of the Tigua Indian Reservation. The Administration, Cultural Center, Meeting House, Housing Area and Teresa Gardens Tracts are located in the metropolitan area of east El Paso, Texas. These Tracts, falling in dense residential and business areas, all contain improvements such as buildings and parking areas; the exception being the Teresa Gardens Tract which is an open area with no improvements. Streets are paved with curb and gutter drainage with vegetation being generally residential types such as lawns, gardens and shade trees. An irrigation ditch runs along a portion of the Housing Area Tract boundary.

The Sabinas Tract and Hueco Tanks Tract are located approximately 15 and 20 miles east of the city limits. The Sabinas Tract is located within a subdivided area known as Horizon properties. However, there are no improvements on the property and access is by way of numerous gravel roads which run in cardinal directions within the subdivision. The land is level and sandy with scattered to moderate creosote and mesquite. Drainage is by way of numerous small arroyos throughout the area.

The Hueco Tanks Tract has a common boundary with the Hueco Tanks State Park. This tract has no improvements and is accessible through numerous gravel roads in and around the State Park. The land is level with evidence of caliche throughout. Vegetation is moderate creosote, cactus, and mesquite.

The mean magnetic declination as determined by NOAA for 1993 is 10 3/4° East.
