SURVEYORS REPORT

SUBJECT: Shoreline determination along a portion of the Laguna Madre in Corpus Christi, Nueces County, Texas.

LOCATION: The property surveyed is an unplatted parcel of land known as Lots 8 and 9, Block 5, Tyler Subdivision, situated near the southern city limits of Corpus Christi with approximately 155 foot frontage on Laguna Madre.

PURPOSE: This survey is being performed to obtain General Land Office approval of the shoreline boundary to satisfy the platting requirements of Corpus Christi and allow the property owner to improve his property.

PROCEDURE: A boundary survey was first completed employing the owners metes and bounds description and monumentation found on the adjoining platted lots to the north and south of this tract. These lines were then projected to the shoreline at elevation +0.81, NGVD '29 measured from benchmarks established by me in my survey at Tropic Isles and later confirmed using GPS. The perimeter boundaries were then tied to the Texas State Plane Coordinate System, South Zone, utilizing GPS equipment based on monumentation established by Corpus Christi (SQ 051). The scale factor at this site was computed to be 0.99995555 and the theta angle = 0 degrees-32 minutes-59 seconds.

On site inspections and a review and comparison of aerial photographs taken in 1948 and 1961 indicate no evidence of artificial fill having been placed along this shoreline.






