Dear Sir:

This acknowledges receipt of your letter of the 15th inst., with which you enclosed field notes and plat of the boundary line between Andrews and Gaines, and Andrews and Winkler counties recently surveyed by Bryan Estes, county surveyor of Andrews county, and assisted by R E Estes for Gaines and J E Whilden for Winkler county, which field notes you state have been approved filed and recorded. From an inspection of these field notes, I fail to find any certificate or endorsement showing the approval, filing and recording, of same.

In regard to the copy to be returned to the General Land Office, your attention is called to Article 1587 Revised Civil Statutes of 1925.

In matters of county boundaries, it is desirable that certified copies of the orders of the county court ordering the survey, and order of the court's approval of same be filed in connection with the field notes.

I am returning the field notes and plat, so that you may place thereon the necessary certificates and when returned to this department, together with copies of the orders of the county court above mentioned, same will have proper attention.

And the Court having considered the field notes and the plats of the above mentioned lines, and it appearing that Winkler and Gaines Counties, were duly served with a certified copy of the order of survey, according to law, and further that said boundaries were made and established in accordance with the laws of the State of Texas, and especially with the law defining the boundaries of Andrews County, Texas, the court is of the opinion that said field notes and plats be hereby accepted and approved.

It is therefore, Ordered, Adjudged and Decreed by the Court that the boundary line of Andrews and Winkler County as set out in the Field Notes of the Andrews-Winkler County, and the Field Notes of the Andrews-Gaines County, Survey, by Bryan Estes be hereby approved, and that said Field Notes be recorded in the Minutes of this Court, and that said plats be filed among the records of Andrews County, in the County Clerk's Office.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that BRYAN ESTES, the duly licensed County Surveyor of Andrews County, Texas be and he is hereby appointed by this court to ascertain by actual survey the boundary, or boundaries, between Andrews County, Texas, and Gaines County, Texas, and between the said Andrews County, Texas, and Martin County, Texas, and between the said Andrews County, Texas, and Winkler County, Texas, and to make and establish the lines and corners along said boundary lines abovementioned, in accordance with the law of the State of Texas, and especially to the law defining the boundaries of Andrews County, Texas.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a certified copy of this order be sent to the County Courts of the said Gaines, Martin and Winkler Counties, which shall be notice to them as required by law to appoint their respective representatives in said survey, which shall be begun by a meeting of all such representatives, together with the said Bryan Estes, in Andrews Andrews County, Texas, on the 9th day of February, A.D.1931.
