

To the Honorable County Courts of Anderson and Houston Counties, Texas.  
Gentlemen:-

We, the Surveyors appointed by the County Courts of Anderson and Houston Counties to locate and define the boundary line between said Counties beg to submit our report of said work. We have located and marked the line from the Neches to the Trinity Rivers, following the original line and the line agreed on by the County Courts of above mentioned Counties, tied in all original surveys crossed by said survey, and established permanent concrete post at initial corners and at each mile of said line, said post being five feet long and eight inches in diameter, reinforced their entire length with steel rods, and set in the ground three feet below the surface and projecting two feet above the surface, back filled and well tamped.

The following are the field notes of the above mentioned survey:

Beginning in the middle of the top of Houston Mound, May 13th, 1915, Thence N 80 Degrees 50 min E with a variation of 8 degrees E at 510 vs cross R. Beeson and S.M. Shirey line S 1130 vs. from Beeson N.E. corner and 1330 vs. from Shirey N. W. corner, at 1199 vs. cross Shirey and W. T. Sadler line, S. 1309 vs. from Shirey to N. E. corner and 1341 vs. from Sadler N.W. corner at 1425 vs. past mile post No. 21 plus 97, at 2570 vs. cross Sadler and Sheridan line, S. 1156 vs. from Sadler N.E. corner, and 1049 vs. from Sheridan N. W. corner, 3382-8/10 vs. past mile post No. 23, at 3519-4/10 vs. cross Sheridan and Durst line, S. 861 vs. from Sheridan N.E. corner, and 2062 vs. from Durst N. W. corner at 5283-6/10 vs. past Mile post no. 24, at 7184-4/10 vs. past mile post No. 25, at 8652 vs. cross Jno. Durst and AT. Rice line, S. 1237 vs from Durst N.E. corner, and 1137 vs. from N. W. corner of Rice, 9085-2/10 vs. past mile post No. 26, at 9212 vs. cross Rice and J. Fitch line S. 2866 vs. from Fitch N. W. corner, at 10,188 vs. cross Fitch and Washington Lewis line S. 1025 vs. from Lewis N.W. corner and Fitch L. Corner, at 10986 vs. past mile post No. 27, at 12886-8/10 vs. past mile post No. 28, at 13503 vs. cross Washington Lewis and Fred Elm line, S 350 vs. from Fred Elm N. W. Corner at 14737-6/10 vs. past mile post No. 29, at 15484-3/10 vs. West bank of Neches River.

Beginning at the same point of Houston Mound and running thence S. 80 deg. and 50 min. W. with variation 8 deg. E. at 141-7/10 vs. cross Beson and Joshep Bishop line, S. 1360 vs. from Beeson N. W. corner and 998 vs. from Bishop N. E. corner at 425 vs. past Mile post No. 21, at 1109 vs. cross Joseph and John Bishop line, S. 920 vs. from their N. E and N. W. corners at 2081 vs. cross John Bishop and J. C. Lively Line, S 876 vs. from Bishop N. W. corner and 460 vs. from Lively N. E. corner, at 2325-8/10 vs. past mile post No. 20, at 3880 vs. cross Lively and R.A. Hodges line, S. 663 vs, from their N. W. and N.E. corner, at 4226-6/10 vs. past mile post No. 19, at 4794 vs. cross Hodges and J. Pennington line, S. 865 vs. from Hodges N. W. corner and 535 vs. Pennington corner N. E at 4899-6/10 vs. deflect course. 38 min. to left, and run S. 80 deg. 12 min. W. Continuing distance from Houston Mound, at 5688 vs. cross Pennington and W.T. Sadler line, N. 85 vs. from Sadler's S. E. corner, at 6127-4/10 vs. past mile post No. 18, at 6192 vs. cross Sadler and R. Pennington line, 496-7/10 vs. W. of Sadler S. E. corner, at 6660 vs. cross R. Pennington W. B. line at J.F.
