I have your favor enclosing surveyor's report of the resurvey and marking of the county line between Bell and Coryell counties as approved by the Commissioners' Court of Bell County March 1, 1920, which report was sent in responce to a letter from this office February 28, 1921, in regard to the correction of surveys along the county boundary between said counties.

As stated in that letter of the 28th, the county boundary between said counties as run and established by D. A. Hammack in 1879 is recognized in this office. By comparison of the report with the Hammack line, it would seem that this last survey is a retrace of the Hammack line and if so, there can be no objection to it except that it seems to have been made under the instructions and authority of the Bell County Commissioners' Court. Fountain shwoing the loacation of the Lampassas and Bell County Corner and bearings for same which report is signed by S. D. Hanna county Surveyor of Bell County and John E. Franks County Surveyor of Coryell County. We also report that in addition to the Starr house and the Live Cak tree at the house bearing the old marks of the County line mention-

ed in the report of Messrs Chalk and Motz of their survey in 1872 we found one other old live oak tree marked with original County line marks

on the Hardeman survey on the Black tract. Messrs Chalk and Motz report from Lampassas and Bell County corner to the J. M. Starr house to be 14 miles and 270 varas while our distance is 14 miles and 824 varas.

Our total distance from Lampassas and Bell County to McLennan County Corner is 34 miles and 508.7 varas while they report the same distance to be 32 miles and 1260 varas, a difference of one mile and 1148.7 varas. There is no question in our minds that we have established our line within a few feet where Messrs Chalk and Motz ran their line in 1872.

We have also calculated the acreage of land of each original surbey lying on either side of the County line and attach to and is hereby made a part of this report.

We have calcualted the acreage of the part of the land having the least acreafe and have taken the abstract acreage of the original tract to calculate the balance of each survey.

## Page three County Line Report

The needle varied from 10/5 to 10.15 during the day and this variation was not the same at the same hour of each day but during the day the variation was practically the same. Therefore we had to use the back sights and the needle each to correct the other. Some points we had as much as 8 miles back sight which enabled us to keep the line straight.

Returning on the correct line we did not cut out the correct line as we did the trial line but made calculations at each mile and at each road crossing and marked the points where mile monuments should be plan-ted and also where monuments should be planted on road crossings. The Trial line just run was cut out clear and sufficient width to be used in retracing and off setting the different monuments. This Trial

line was over very rough mountainous country and across several deep canions, for considerable distance, and it rained on us a great portion of the time making the surveying very slow and diffucult. We had several different Chainmen but all were under oath while

surveying. We begun with W. L. Pegram, of Killeen as rear chainman and Cox as Front Chainman. F.

The Corner of McLennan, Bell and Coryell Counties is located in the

Miles J. West Surbey, 307 vares, S.19W and 83.5 vrs. S.71 E. from the N. W. corner of the M/les J. West Survey. This corner is N. 60 E. 33 Miles and 1524 varas from the Coryell and Lampassas Corner on the Bell County North line and 34 Mile and 508.7 varas from the Lampassas and Bell County Corner, with a variation of 10.23.

Beginning at the Coryell County S. E. corner and Bell County N. E. corner, as above described, and the McLennan County Corner where we have placed a cement Monument properlay marked with reference to the three corners.

Corners. Thence, S. 60.W.129 varas crossed the West line of the Miles J. West and the East line of the W. P. Johnson survey, and the 431 varas crossed the recognized East line of the V. L. Evans Survey, N. 19. E. 847 varas from its S. E/ Corner. At 1554 varas crossed the South line of V. L. Evans 729 varas N. 71 W. from S. E. Corner of same. and 104 varas N.71 W. from N. E. corner of J. N. O. Smith survey. ONE MILE Monument set in John Ferrymans field 127 varas N.60E from his South line. Set LINE MONUMENT on road between Cornethers and Fisher

his South line. Set LINE MONUMENT on road between Carrothers and Fishgrates tracts. In the J. N. O. Smith Survey. 50 feet S.30.E from a large cotton wood tree which is known by the settlers as being the distance from this tree that other Surbeyers ran a County line. W. corner of her chimney, and N.71W 218 varas and N. 60E 52 varas from Smiths S. E. corner. J. N. O. Smith survey. At 270 varas plus 2 mules crosses the lower West line of Luther Smith survey and the East line of the John Craddic 172 varas S 19 W. from their North Corner.

Set Mile Monument in the John Craddic survey. No. 3. in J. F. Tilleys pasture from which a Live Cak marked X bears S. 45. 30 W 30.4 varas. At 3 miles 680 varas crosses the West line of the John Craddic and

the East line of the C. Calliote curvey and at 830 varas crosses the West line of the xsaid Calliote survey and the East line of the Chas. LaJoice line of the xsaid Calliote survey and the East line of the Chas. LaJoice surveys, 675 varas N. 19E from said La Joice S. E. corner. Atl750 varas crosses Payton Bland North line. From J. F. Tilleys S. W. cormer N. 192 260 varas N. 71 W 100 varas set a line Monument in funce on North Side of road from Buck Horn to the Bend. At 4 Miles 1 50 varas Set Mile Monument No. 4 on South Bank of Leon River. At 4 Miles 142 varas a small ash tree on the bank of the Leon River N.30.3.3/5 varas from a large forked Elm tree on bank of river marded with 4 backs on N. W. side.

N.30.#.3/5 Varas from a large forked Eim tree of bank of river marded with 4 hacks on N. W. side. Continuing through Mr. Carligles land and the Payton Blands survey, passes 50 feet S. 30.W from Mr. Carligles house and 50 **feet** N 30.E from a file driven in the groung at the root of a mulberry tree. We were told by citizens there that one previous survey of the County line passed at the Carlize house and another was marked by the file by the mulberry tree. This information and that of the cotton wood tree and the elm stump mentioned above in this report indicates that our line divides the distant

mentioned above in this report indicates that our line divides the distance between the two previous sruveys which seem to have been made since the Chalk and Motz survey was made.

Set a line monument on the North side of the road at the corner of Carliles Field and at the angle of the public road and near Carliles house. On the Moody and Grove road.

Set 5 MILE Monument in Kennedys pasture on N. W. Point of mountain in the Payton Bland survey.

At 5 miles and 836 varas crosses Payton Blands Survey West line,

ed the Copperas and Okalla road, ( at this point, tradition had the co-line 100 yards S. 30.E from our line. )

At 3800 varas set a stake on side of mountain 50 varas from top. On Monday Morning, May 26th. we had a clear back sight of 2 miles and the back sight registered the vernier at 10.-8. This TRIAL LINE just run was kept straight by continual back sights from high points on mountains to flag poles securely planted on all elevated points and the variation of the magnetic needle not allowed to go below 10.5 nor above 10.15 and whenever this occurred, the line was retraced and the error corrected, HENCE we have a straight trial line from the Coryell and Lampassas corner on the North line of Bell County to this point S. 30.W 348. 5 varas, from the TRUE CORNER.

Correcting the course we set on a variation of 10.23 for the return running of this correct line back to the Coryell, and Lampassas corner on theNorth line of Bell County and continueing on to the Lampassas and Bell Counties corner.

Report of Survey of County Line

Between Lampassas, Coryell and Bell County.

Made by S. D. Hanna, County Surveyor of Bell County and John E. Franks County Surveyor of Coryell County, under instrucións and by the authority of the Bell County's Commissioners Courtyat its term 1919 and approved by

the Commissioners Court of Coryell County at it term, 1919. We were instructed to legally bocate the County line and mark each mile with a cement monument properly marked, and also to place a cement monum-ent on the correct line at the crossing of all important roads.

We met at a cedar Post 10 inches square and about three feet high, mark-ed indicating Lampassas and Coryell County Corner and the letter B on the S. E. side indicating Bell County Line. This Monument was made by the SurveyOr who was appointed by Lampassas

and Coryell Counties to settle and compromise the line between Lampassas and

Coryell Counties, without reference to the Bell County Corner. From this Cedar Monument we set our Gurly Mountain Transit on a variation of 10-30 variation and ran N.30 W one mile and found another simplar Cedar Monument marked One on one side and 30 on another side. We then decided that this was the established line between Coryell and Lampassas Counties. The report of this line is of record in Coryell County and was made without the assistance or endorsmant of the County Court of Bell County.

The fact that this Corner of Lampassas and Coryell County called to corner in the North line of Bell County led S. D. Hannas County Surveyor of Bell County to believe that this could not be the Bell, Lampassas and Coryell Corner, therefore he phoned to Mr. W. H. Fountain, County Surveyor of Lam-Corner, therefore he phoned to Mr. W. H. Fountain, County Surveyor of Lampassas passas County to come and assist in locating the propper corner of Lampassas and Bell County. Mr. Fountain came and together with S. D. Hanna, County Surveyor of Bell Bell County and Mr. John E. Franks, County Surveyor of Cory-ell County, we made a thorough survey of all conditions and surroundings and evidences connected with the respective corners of Bell, Lampassas and Coryell Counties and found beyond any question that Lampassas and Coryell Counties Counties and found, beyond any question that Lampassas and Coryell Counties had made a compromise line, which we have described and also that the prigi-nal Corner of Bell and Lampassas Counties was S. 60. W, 884.7 varas from the above described corner of Lampassas and Coryell Counties. This Corner of Bell County was either found or established by Mr. Chalk

D. Hanna and Mr. John E. Franks proceeded to sur-vey the County line between Coryell and Bell County.

We begun our measurement at the Coryell and Lampassas corner, on the North line of Bell County.

At 1227 varas the channel of clear creek, course South, at 1700 varas the North bank of a prong of clear creek, at 1850 varas N.30.W. 13.7 varas a planted cedar monument set on the brink of steep rock bluff, some what si similar to the cedar monument described at the Coryell and Lampassas corner though considerably disfigured and bearing no marks, At 2020 varas we though considerably disfigured and bearing no marks, At 2020 varas we passed N.30.W from a large live oak with four old hacks on N. W. side, five feet.

At this point we decided we were on the correct line and established/ our course on N.60 E. with a minimum variation of 10.5.

With great care and precision we ran this line through to the McLenn-an County Corner. A Trial Line.
